AMENDMENT TO DECLARATION
OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS
OF WESTERN HILLS,
A SUBDIVISION IN SARPY COUNTY, NEBRASKA
LOTS 1 THROUGH 168, AND LOTS 177 THROUGH 185, INCLUSIVE

This Amendment, made on the date hereinafter set forth, is made by the undersigns, constituting the duly-elected officer members of the Board of Directors of the Western Hills Homeowners Association, a Nebraska non-profit corporation (the "Declarant"), on behalf of the Owners of 177 Lots within Western Hills, a Subdivision in Sarpy County, Nebraska, specifically Lots 1 through 168 and Lots 177 through 185, inclusive (the "Owners"). The undersigns hereby approve and consent to the adoption of this Amendment to the Declaration of Covenants, Conditions and Restrictions of Western Hills, a Subdivision in Sarpy County Nebraska (the "Declaration"), executed on March 10, 1992 and filed as Instrument No. 92-04283 in the Office of the Register of Deeds of Sarpy County, Nebraska, and agree as follows:

WHEREAS, pursuant to ARTICLE III, Section 2 of the Declaration, the Declaration may be amended by an instrument signed by the Owners of not less than sixty percent (60%) of the Lots covered by the Declaration ; and

WHEREAS, sixty percent (60%) or more of the Owners of Lots 1 through 168 and Lots 177 through 185, inclusive, voted to amend ARTICLE I Section 4 of the Declaration by completing and signing a Covenant Amendment Ballot (the "Ballot"); and

WHEREAS, as of the 28th day of October, 2012, the Owners returned 128 Ballots "In Support" of the Amendment, and 1 Ballot "In Opposition" to the Amendment, which Ballots are attached hereto as Exhibit A, and 47 Ballots were not returned; and

WHEREAS, the undersigns have reviewed the Ballots and affirm that the requisite sixty percent (60%) of the Owners voted "In Support" of the Amendment; and

WHEREAS, the undersigns and the Owners hereby desire to modify and amend the Declaration in the manner described below; and

A

WHEREAS, this Amendment shall relate to and affect certain real estate legally described as follows:

Lots 1 through 168, and Lots 177 through 185, inclusive, Western Hills, a Subdivision, as surveyed, platted and replatted, and recorded in Sarpy County, Nebraska.

NOW THEREFORE,

1. The Declaration is hereby amended such that the text of ARTICLE I, Section 4 of the Declaration shall be deleted in its entirety and the following shall be substituted therefor:

“The exposed front foundation walls and any exposed foundation walls facing any street must be constructed of or faced with brick or other material approved by Declarant. All driveways must be constructed of concrete, brick, paving stone, or laid stone. All foundations shall be constructed of concrete, concrete blocks, brick or stone. Fireplace chimneys shall be covered with brick, or other material approved in writing by Declarant. The roof of all Improvements shall be covered with:

- a. **Wood shakes or shingles or synthetic shake shingles with the appearance, color, texture, and thickness of natural wood shakes; or**
- b. **Minimum two-piece fiberglass laminated shingles including the Heritage® Series Laminated Asphalt Shingles manufactured by TAMKO® or the Presidential Shake™ by CertainTeed, the color of all shingles shall be weathered wood and shall weigh no less than 235 pounds per 100 square feet; or**
- c. **Any material pre-approved by the Architectural Committee; provided, however, that the Architectural Committee shall only approve of materials similar in appearance, texture and quality as those materials enumerated in items (a) and (b) above.”**

2. Except as hereby amended, the Declaration, as well as the following Instruments, remain in full force and effect:

- a. Amendment to Declaration of Covenants, Conditions and Restrictions for Western Hills, a Subdivision in Sarpy County, Nebraska, recorded in Instrument No. 94-21526, filed on October 3, 1994 in the Office of the Register of Deeds in Sarpy County, Nebraska (prohibiting construction of perimeter fences on any lot abutting the golf course); and
- b. Instrument No. 94-08574, filed on April 27, 1994 in the Office of the Register of Deeds in Sarpy County, Nebraska (addition of Lots 177-185, Inclusive, Western Hills Replat); and
- c. Instrument No. 94-07186, filed on March 31, 1994 in the Office of the Register of Deeds in Sarpy County, Nebraska (notice of assignment of rights as Declarant).

NOW, THEREFORE, the duly-elected undersigns of the Declarant, pursuant to ARTICLE III, Section 2 of the above-described Declaration, do hereby amend ARTICLE I, Section 4, by

adding the language set forth in Paragraph 1 herein above, having to do with the composition of roofing materials.

IN WITNESS WHEREOF, the duly-elected undersigns of the Declarant have executed this Amendment to the Declaration of Covenants, Conditions, Restrictions and Easements of Western Hills, a Subdivision in Sarpy County, Nebraska, for Lots 1 through 168 and Lots 177 through 185, Inclusive, upon the date noted on each respective signature below, and the Owners have executed and confirmed their approval of the same as set forth on their respective Ballots.
