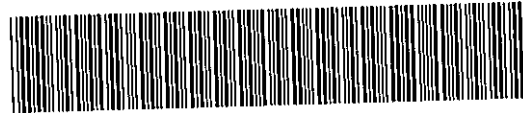

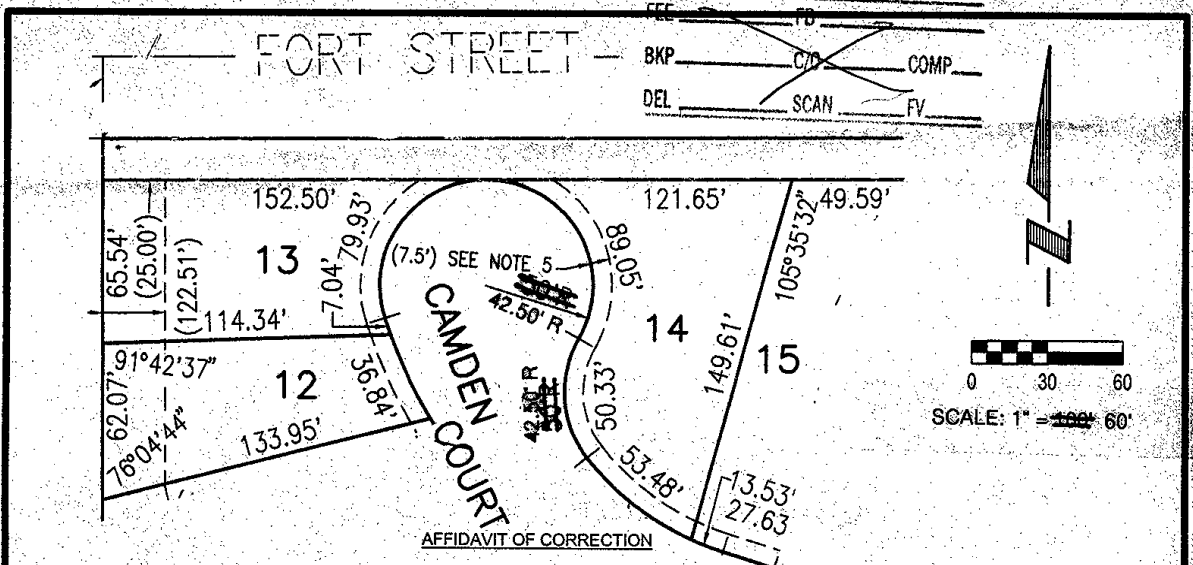

**AFFIDAVIT OF CORRECTION**

To correct the drawing scale and the error in radii for the cul-de-sac on Camden Court, located in Westin Hills West Two, a subdivision located in the NW1/4 of the NE1/4 of Section 2, Township 15 North, Range 11 East of the 6<sup>th</sup> P.M., Douglas County, Nebraska.

The drawing scale should read 1" = 60' instead of 1" = 100'.

The radius of the cul-de-sac to read 42.50 feet instead of 50.00 feet. The arc length of lots 13 and 14, Westin Hills West Two are 15' unchanged.

The radius of Camden Court adjacent to Lot 14, Westin Hills West Two to read 42.50 feet instead of 50.00 feet. The arc length of Lot 14, Westin Hills West Two is unchanged.

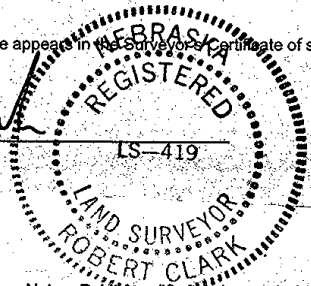

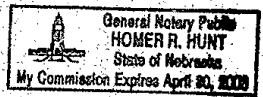
