CORRECTIVE QUITCLAIM DEED

1. On May 14, 1999, Southview, Inc., a Nebraska corporation, as Grantor, conveyed an undivided one-fourth interest in the water and mineral rights to real property to Large Partnership, Ltd., a Nebraska limited partnership, as Grantee, pursuant to a Quitclaim Deed which was filed of record with the Lancaster County Register of Deeds office on May 27, 1999 as Instrument No. 99-29586 (the "Quitclaim Deed").

3. The undersigned parties wish to enter into this Corrective Quitclaim Deed to correct the errors contained in the Quitclaim Deed.

NOW, THEREFORE, in consideration of the foregoing, the undersigned hereby agree as follows:

A. The legal description of the real estate described on Exhibit "A", which was attached to the Quitclaim Deed, is hereby replaced with the legal description of the real estate described on Exhibit "B", which is attached hereto and incorporated herein by this reference.

B. The effect of this Corrective Quitclaim Deed is that Grantor, Southview, Inc., hereby quitclaims and conveys an undivided one-fourth interest in the water and mineral rights to the real estate legally described on Exhibit "B" to Grantee, Large Partnership, Ltd., which were reserved by Grantor in the Warranty Deed filed with the Lancaster County Register of Deeds office as Instrument No. 99-29584.

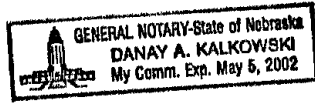

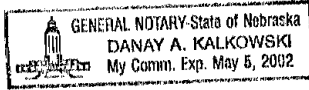
