PERMANENT SIDEWALK EASEMENT

This Indenture and Grant of Easement made this 24 day of JULY,
1975, between John E. North, Trustee

hereinafter referred to as "Grantors", in favor of Sanitary and Improvement District No. 272, Douglas County, Nebraska, hereinafter referred to as "SID", and its successors and assigns, including but not in limitation of the City of Omaha, Douglas County, Nebraska, a municipal corporation, hereinafter referred to as "City".

WITNESSETH:

That said Grantors in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to Grantors in hand paid by said SID, the receipt whereof is hereby acknowledged, does or do hereby grant, sell, convey and confirm unto said SID and City and their assigns forever, the right to use, construct, build, maintain, repair and reconstruct a sidewalk together with all appurtenances, and other applicable equipment pertaining to any sidewalk, in, the parcel of land described as follows, to-wit:

The consideration recited includes damages for change of grade, if any, and any and all claims for damages arising from change of grade or grading are hereby waived.

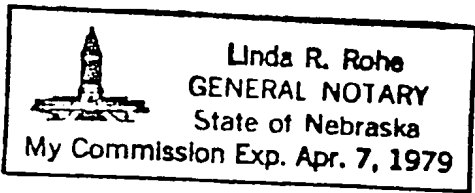

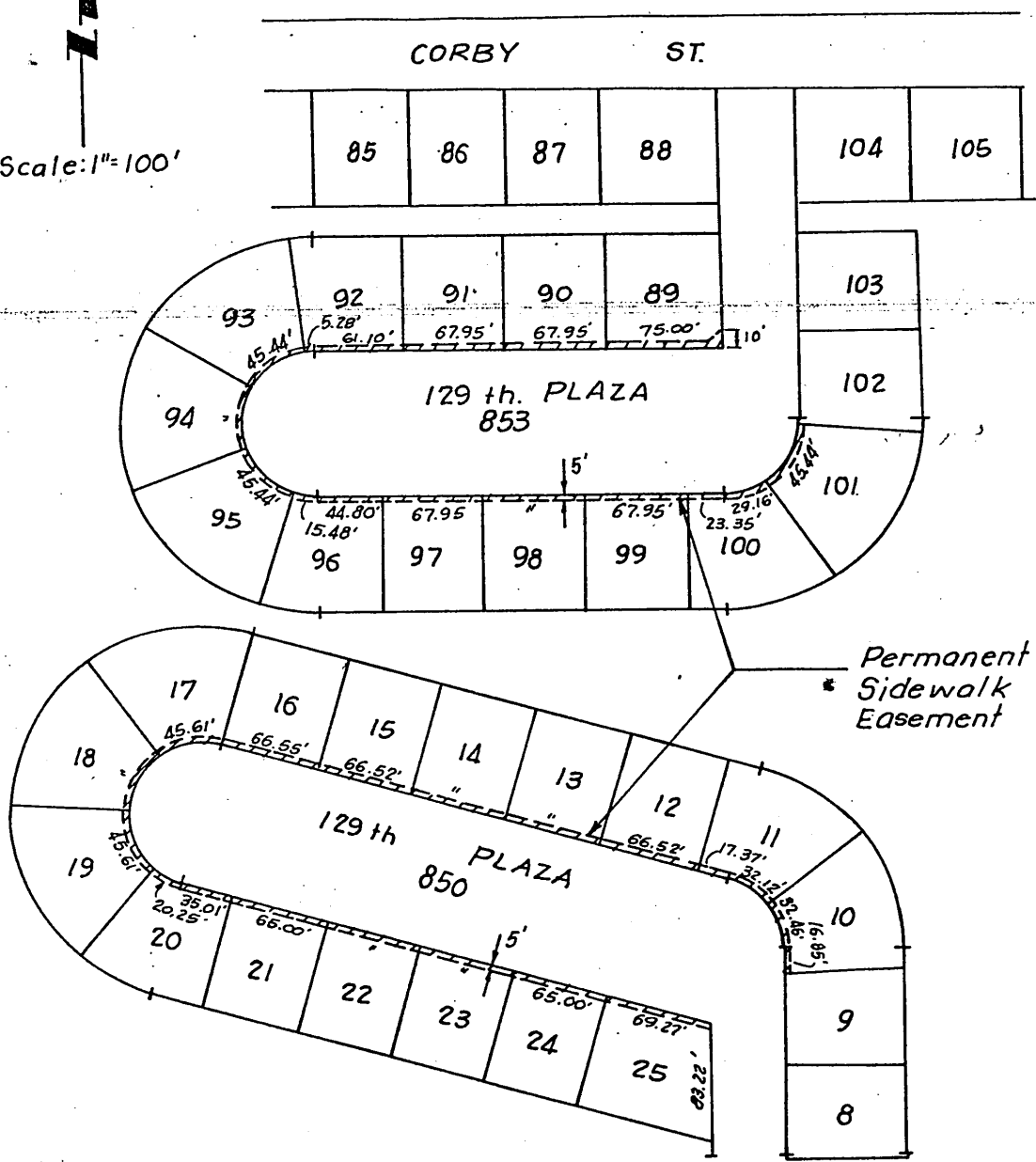


EXHIBIT "B"

DOUGLAS COUNTY, NEBRASKA

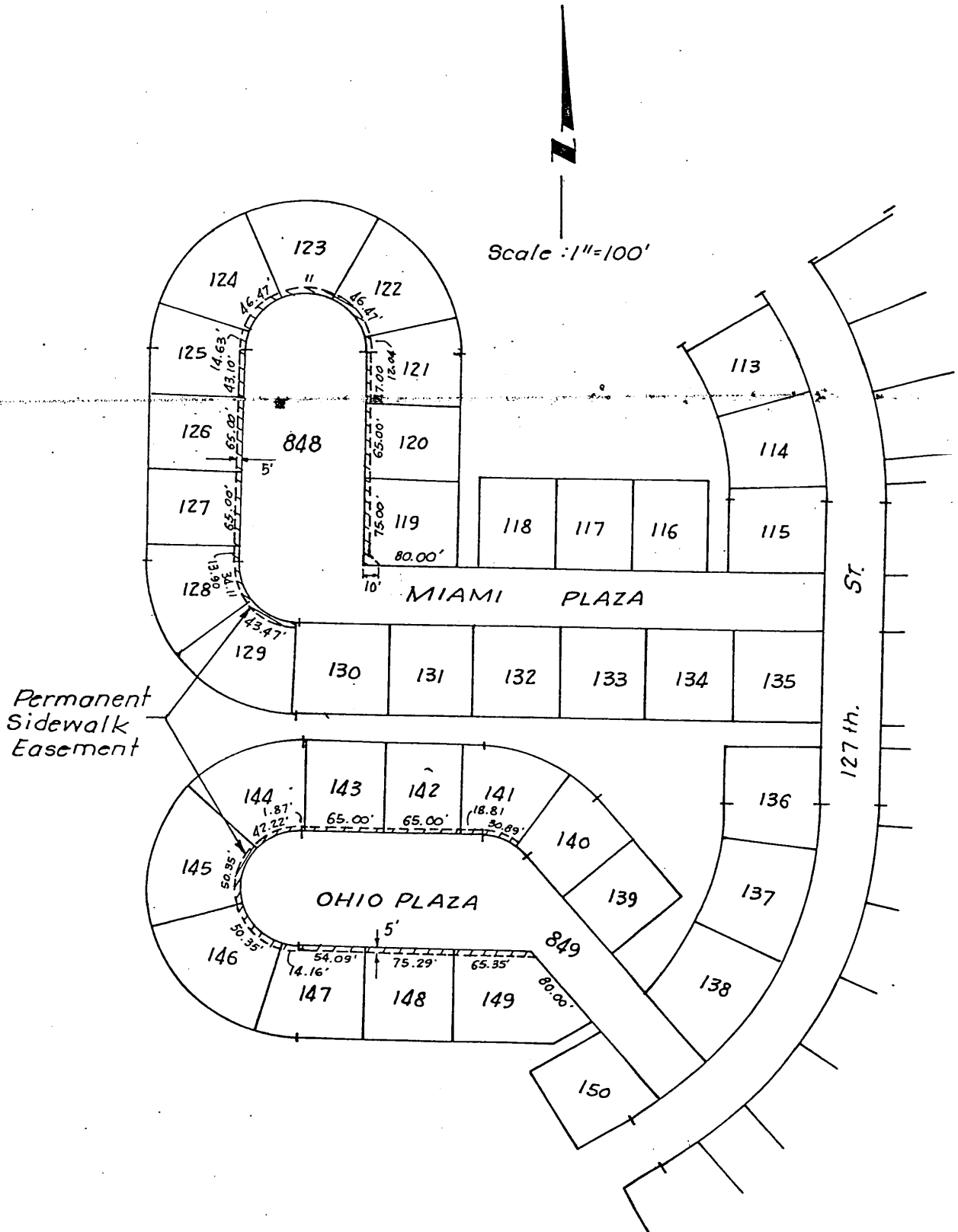


EXHIBIT "D"

SIDEWALK EASEMENT S. & I. D. No. 272 DOUGLAS COUNTY, NEBRASKA

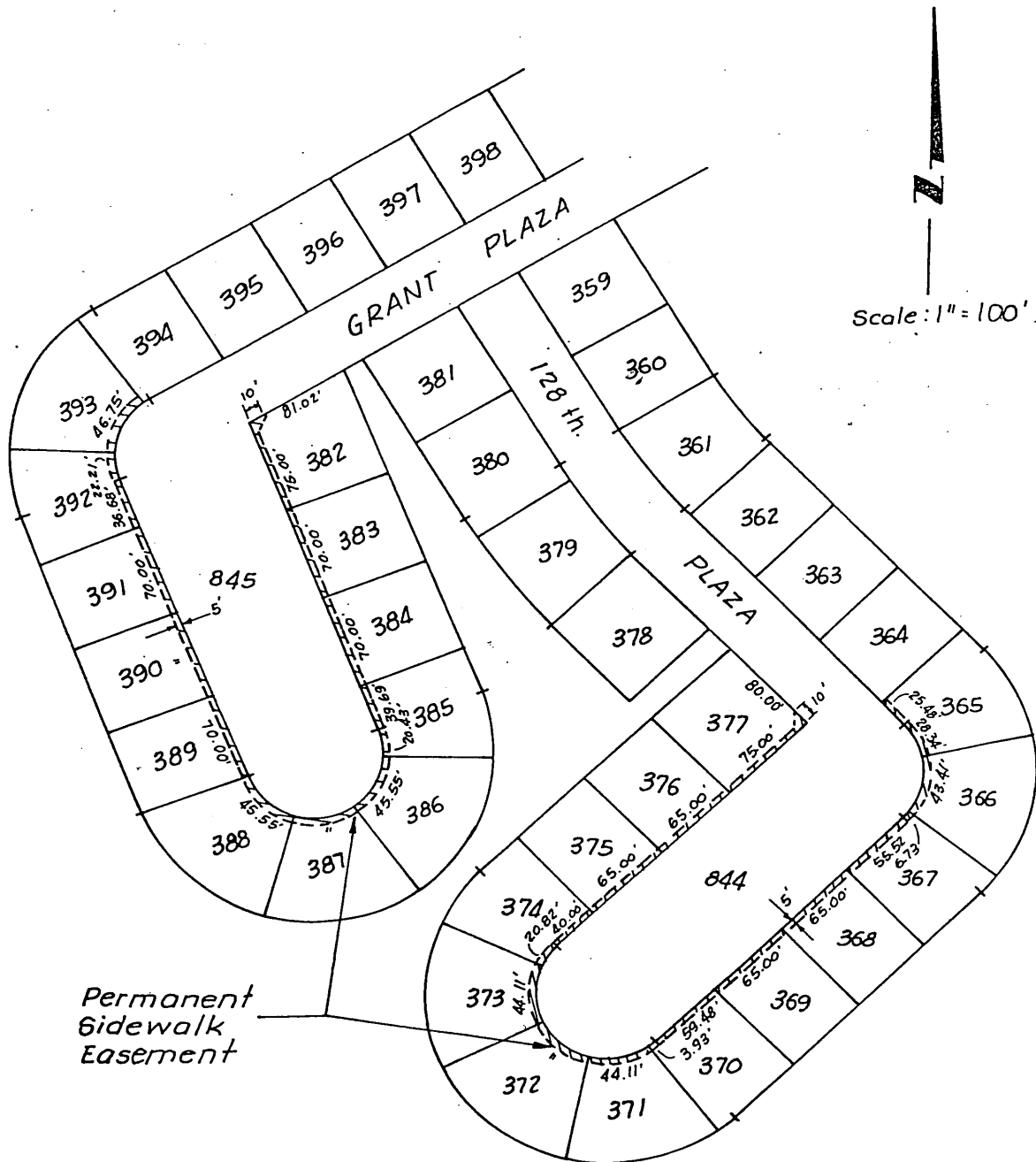


EXHIBIT "E"

SIDEWALK EASEMENT S. & I. D. No. 272 DOUGLAS COUNTY, NEBRASKA

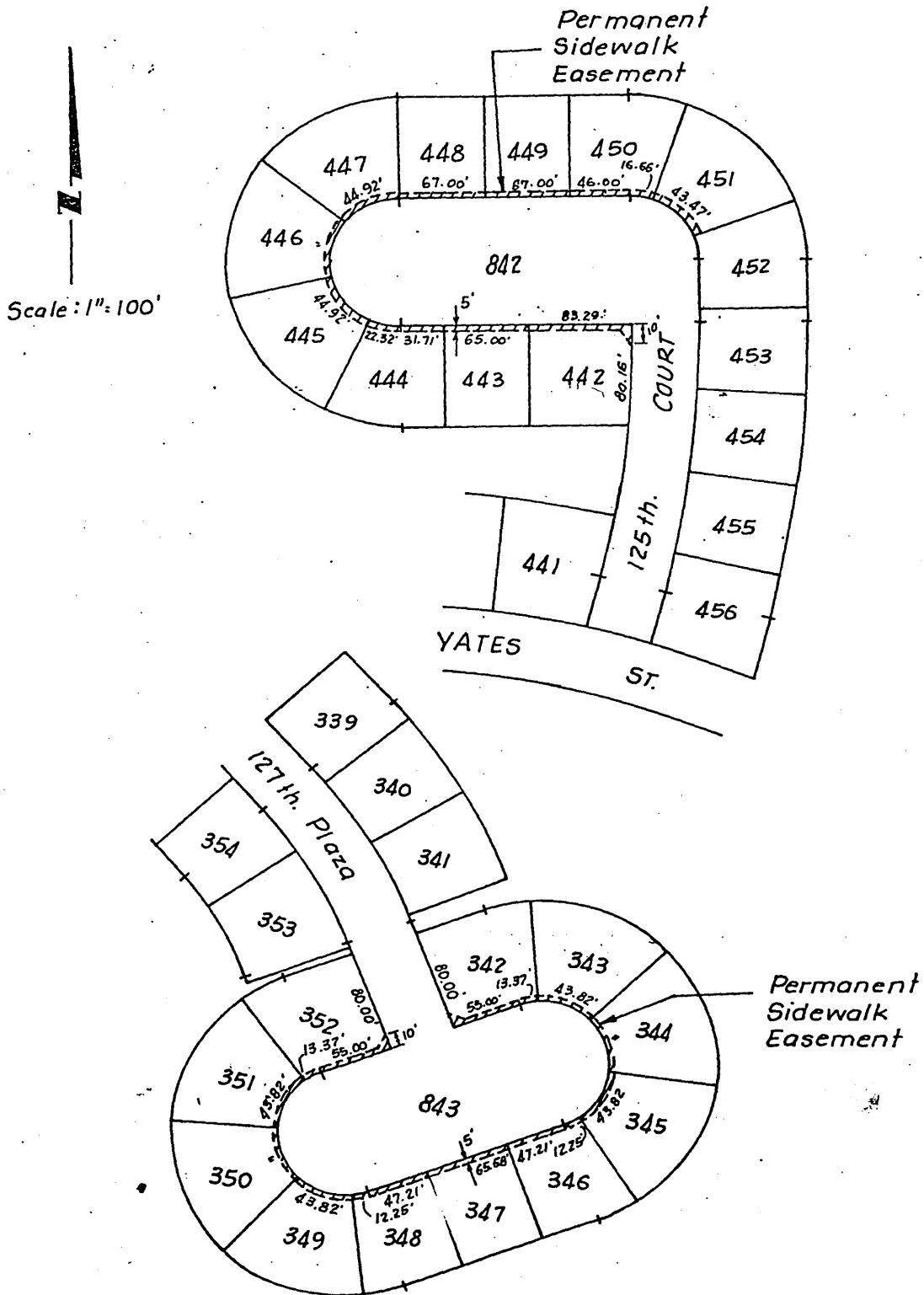

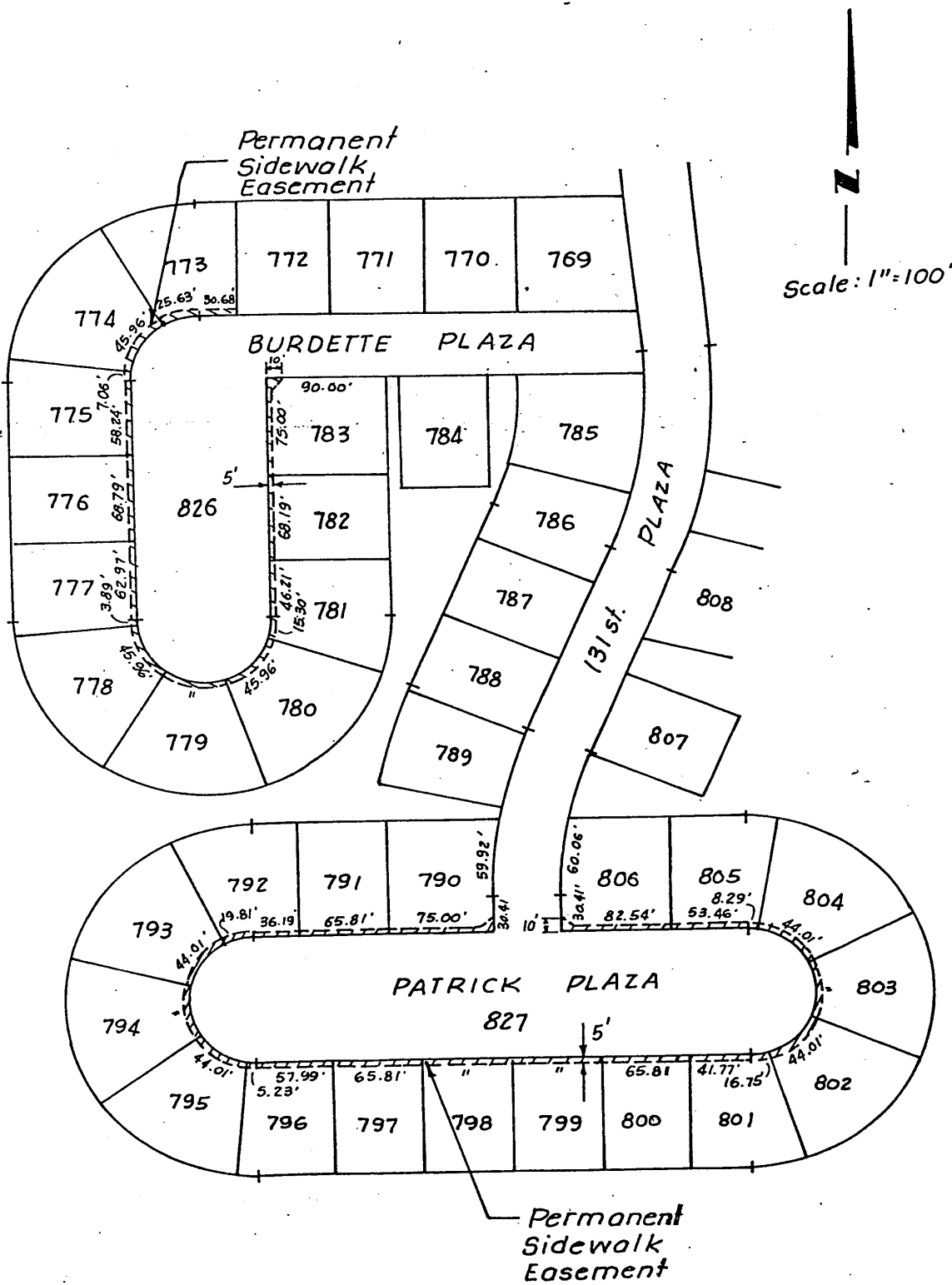
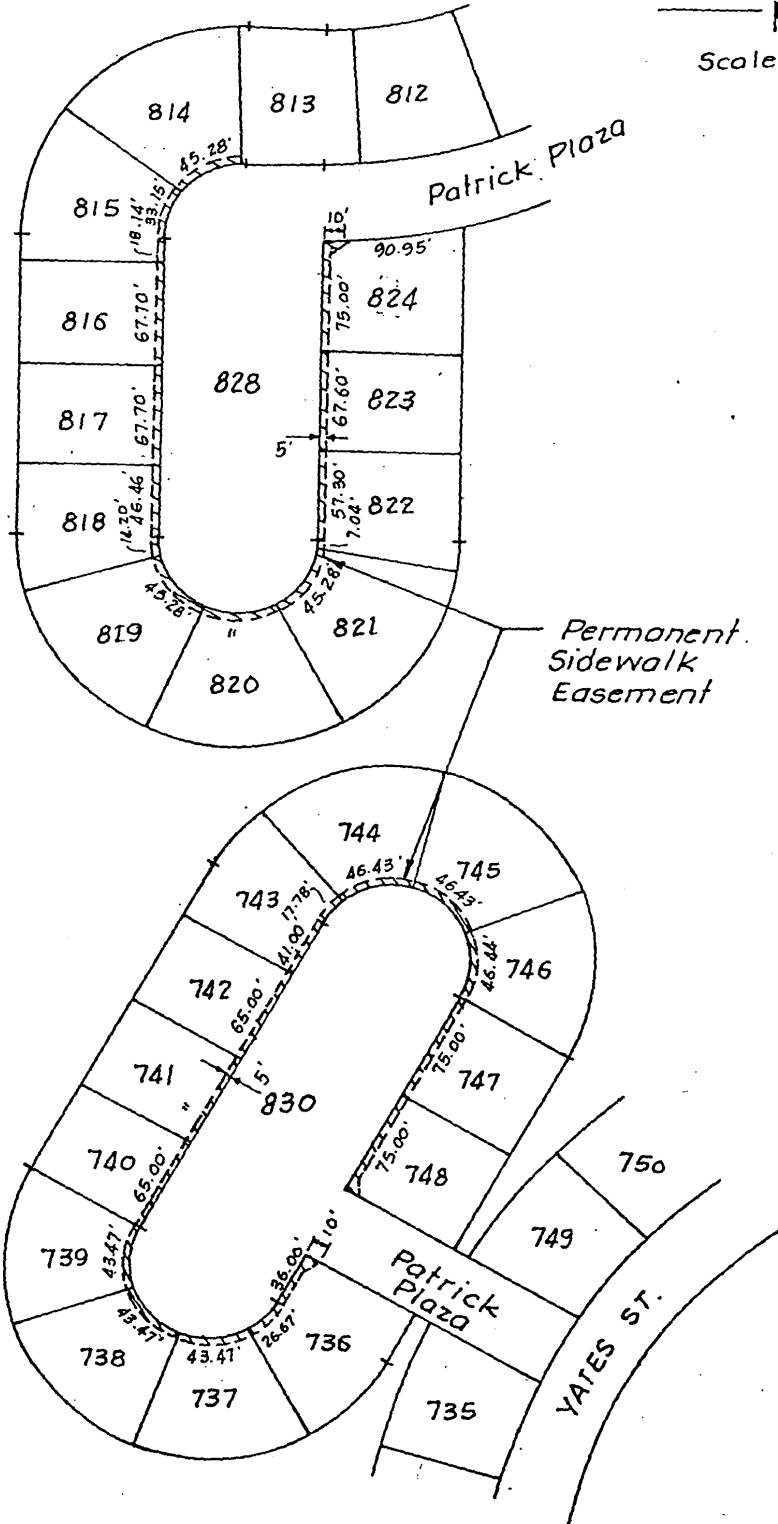
