This conveyance is made subject to the right of those individuals or entities lawfully occupying the right of way conveyed. The State of Nebraska conveys to the City of Omaha, Nebraska, all of its rights to regulate, limit or control, those non-highway uses of the conveyed right of way which have been allowed by the State of Nebraska pursuant to permits, license or easement, it being understood that future occupancy of the conveyed property for non-highway uses shall be controlled by the City of Omaha, Nebraska.


The State of Nebraska, Department of Roads, reserves an easement for the operation, maintenance and use of any and all existing utilities which are located over, under or upon the above described tract.


