upon, over and under a strip of land <u>one rod</u> wide across the land which the undersigned own or in which
the undersigned have any interest in and the Southwest Quarter (SW $_4$) all lying East of Interstate Highway 80, in Section
Eight (8) T 14N, R12E
Township of
The Northwesterly boundary of said one rod strip shall be a line parallel to
and 13½ feet Northwesterly of the first cable or lightguide laid, which cable or lightguide shall have its location indicated upon surface markers set at intervals on the land of the undersigned or on adjacent lands. The undersigned for themselves, their heirs, successors and assigns, hereby covenant that no structure shall be erected or permitted on said strip. The grantees agree that the said cables or lightguides shall be buried below plow depth in order not to interfere with the ordinary cultivation of the strip, and to pay for damages to fences and growing crops
arising from the construction and maintenance of the aforesaid systems
