hereinafter referred to as "Grantee", WITNESSETH:

That the Grantors, in consideration of the sum of one Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, do hereby grant to Metropolitan Utilities District of Omaha, its successors and assigns, an easement and right of way to lay, maintain, operate, repair, relay and remove, at any time, pipelines for the transportation of gas and water and all appurtenances thereto, together with the right of ingress and egress to and from the same, on, over and through lands described as follows:

Several strips of land lying in lots 1, 15. 16, 88, 89, 90, 91, 103 l16, 117, 118, 119, 159, 169, 170, 176, 177, 178, and 482 of Brookhaven a subdivision as now platted and recorded in Douglas County, Nebraska. Said strips being more particularly described as follows:

A strip of land lying in lots 1, 103, 178, 177, 176, 170 and 169, said strip being five (5) feet wide lying along and parallel to the southerly right of way line of Washington Street, said strip being all that portion of said lots lying within five (5) feet of said right of way line.

A strip of land lying in lots 15, 15, 91, 90, 89, and 88, said strip being five (5) feet wide lying along and parallel to the northerly right of way line of Madison Street, said strip being all that portion of said lots lying within five (5) feet of said right of way line.

A strip of land lying in lots 116, 117, and 118, said strip being five (5) feet wide lying along and parallel to the westerly right of way line of 109th Street, said strip extending from the southwesterly property line of lot 118 to a point thirty (30) feet northeasterly of the southwesterly property line of lot 116.

A strip of land lying in lots 119 and 159, said strip being five (5) feet wide lying along and parallel to the southerly right of way line of Madison Street, said strip being all that portion of said lots lying within five (5) feet of said right of way line.

- 2. Grantee shall restore the surface of the soil excavated for any purpose hereunder, as near as may be reasonably possible, to the original contour thereof and as soon after such work is performed as may be reasonably possible to do so.
- 3. Nothing herein contained shall be construed as a waiver of any rights of Grantors, or duties and powers of the Grantee respecting the ownership, use, operations, extensions and connections to any gas main and/or water main constructed and maintained hereunder.




