AGREEMENT

This Agreement made and entered into this 27th day of 1990 by and between Sanitary and Improvement District No. 294 of Douglas County, Nebraska ("SID #294") and Construction Sciences, Inc., a Nebraska corporation ("CSI").

RECITALS:

- CSI is the owner of Lot 481, Brookhaven, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.
- 2. SID #294 has levied special assessments against such property to pay for the cost of installation of public improvements which specially benefitted such lot.
- $4.~\rm CSI$ is in the process of replatting said Lot 481 into 19 single-family lots and has requested that SID #294 "lift" and relevy such special assessments against the replatted lots.
- 5. SID #294 is unwilling to lift and relevy except upon the terms and conditions contained herein.

IT IS THEREFORE AGREED AS FOLLOWS:

- 1. SID #294 shall lift the current Lot 481 Brookhaven special assessment amount plus accrued interest thereon and costs and relevy such amount in ten equal assessments, one each on Lots 1 through 8, inclusive, 18 and 19, Brookhaven Replat I. Said assessments shall be payable in five equal installments commencing one year from the date of relevy with a current interest rate of 10% and a delinquent rate of 12%.
- 2. The present Covenants on Lots 1 479 Brookhaven as filed in Book $\underline{613}$ at Page $\underline{454}$ in the Office of the Register of Deeds of Douglas County, Nebraska shall be and hereby are extended to Lots 1 through 19, inclusive, Brookhaven Replat I.
- 3. CSI and/or any of its related companies or entities will construct on such Replat I lots only Signature Series homes or better.
- 4. This Agreement shall be filed of record in the Office of the Register of Deeds of Douglas County, Nebraska against the following properties, to-wit:

Lots 1 through 19, inclusive, Brookhaven Replat I, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.
