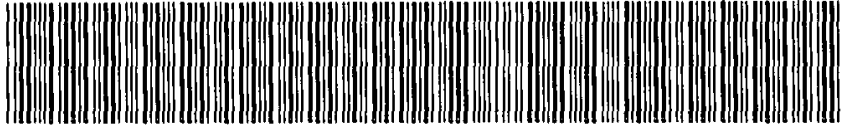

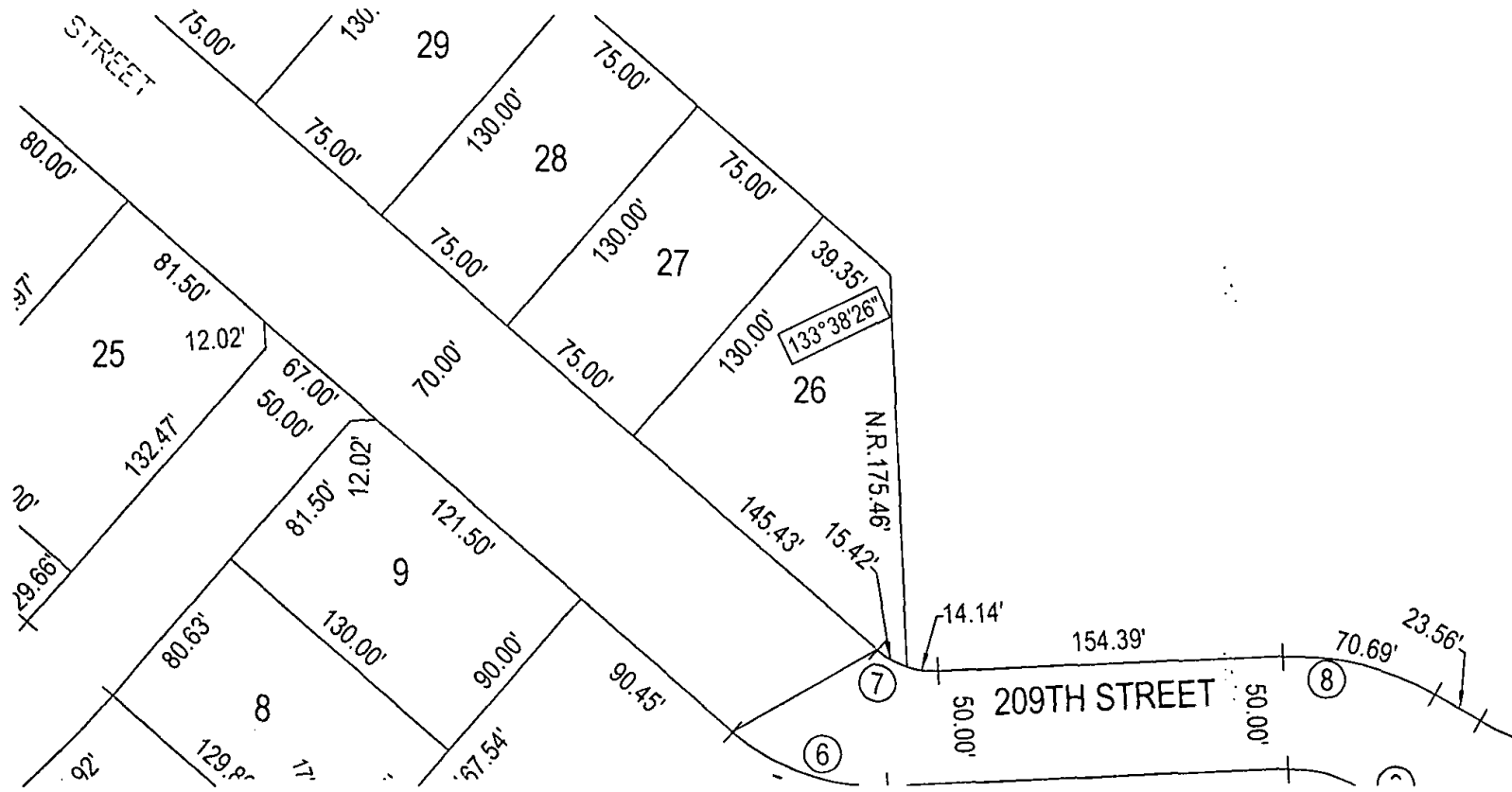

The Northeast Angle dimension in Lot 26 should read 133°38'26".

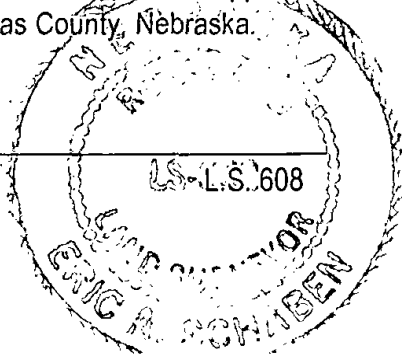
