

SURVEYOR'S CERTIFICATE


I hereby certify: That I have accurately surveyed and staked with iron pipe all corners of all lots, blocks, streets, amenues, angle points and ends of all curves in this plat of Hargleroad's Military, an addition in Douglas County, Nebraska, and that said plat is a part of the NW-1/4 of Section 2, Township 15 North, Range 12 East of the 6th Principal Meridian, all in Douglas County, Nebraska, described and bounded as follows:

Beginning at the S.E. Corner of the NW 1/4 of said Section 2, thence running west along the south line of the NW 1/4 of said Section 2 a distance of 1346.6 feet, thence turning an angle of 90° to the right and running north a distance of 190 feet, thence turning an angle of 90° to the right and running east a distance of 169 feet, thence turning an angle of 90° to the left and running north a distance of 615 feet, thence turning an angle of 90° to the right and running east a distance of 570.42 feet, thence running northeasterly along a curve to the left whose radius is 570 feet a distance of 387.87 feet, thence running northeasterly along the tangent to the previous curve a distance of 274.58 feet to a point on the southwesterly line of Military Avenue, thence turning an angle of 90° to the right and running southeasterly along the southwesterly line of Military Avenue a distance of 60 feet to a point on the east line of the NW 1/4 of said Section 2, thence turning an angle of 390 101 to the right and running south along the east line of the NW 1/4 of said Sec. 2 a distance of 1058.01 feet to the point of beginning.
