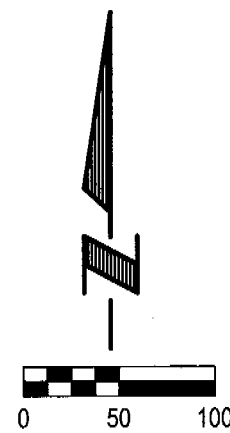
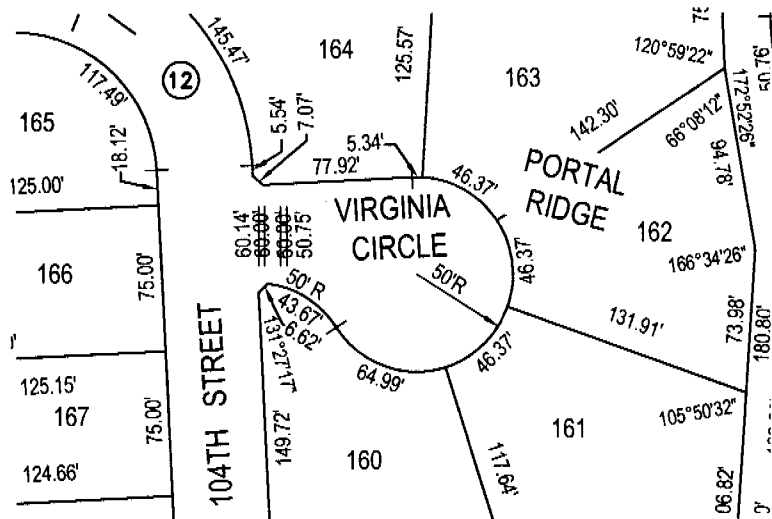

 The dimension of Virginia Circle to read 50.75 feet instead of 50.00 feet.

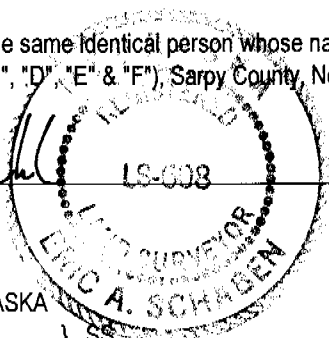

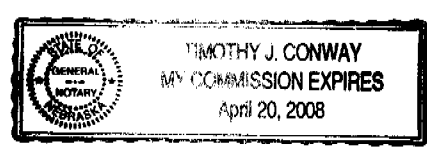
