

WHEREAS, it has proved impracticable to bury said line under and beneath a certain stream and the grantors have agreed that said line may be carried above ground across the above mentioned stream;

NOW THEREFORE, in consideration of the sum of Seventy Five Dollars in hand paid, receipt of which is hereby acknowledged together with such damages as may be sustained, the undersigned hereby agree that said easement agreement, be and is hereby amended, and said Socony-Vacuum Oil Company, Incorporated, its successors or assigns, is hereby granted a right-of-way to lay, maintain, alter, repair, inspect, operate and remove said pipe line above ground, over and across said stream, at a height above mean high water mark and the level of the ground adjacent to said stream, and the right to install, erect and maintain such necessary piling, piers, supports, frames, cables and other equipment as may be necessary and required to support said pipe line above ground across said stream.

It is further understood that the location of said pipe line across said lands will not be changed except as hereinabove set forth and all the terms, covenants, and conditions of said right-of-way agreement, hereinabove described, shall be and continue in full force and effect.

AGREEMENT  
WHEREAS, the undersigned are the present owners of  
certain property over which Socony-Vacuum Oil Company, Incorporated  
has been granted a right-of-way for the construction, maintenance,  
and operation of a pipe line on, over and through certain  
lands situated in Washington County, Nebraska, described as  
follows:

West Half of Northeast Quarter, also Northwest  
Quarter of Southeast Quarter of Section 18-17N-  
12E

WHEREAS, said right-of-way agreement provides that said pipe line shall  
be buried to such a depth as not to interfere with the ordinary cultivation of land; and

WHEREAS, it has proved impracticable to bury said line under and be-  
neath a certain stream and the grantors have agreed that said line may be carried above ground  
across the above mentioned stream;

NOW THEREFORE, in consideration of the sum of Seventy Five Dollars in  
hand paid, receipt of which is hereby acknowledged together with such damages as may be sub-  
stained, the undersigned hereby agree that said easement agreement, be and it is hereby amended,  
and said Socony-Vacuum Oil Company, Incorporated, its successors or assigns, is here by granted  
a right-of-way to lay, maintain, alter, repair, inspect, operate and remove said pipe line above  
ground, over and across said stream, at a height above mean high water mark and the level of the  
ground adjacent to said stream, and the right to install, erect and maintain such necessary pil-  
ing, piers, supports, frames, cables and other equipment as may be necessary and required to sup-  
port said pipe line above ground across said stream.

It is further understood that the location of said pipe line across
