ORDINANCE NO. 2290

AN ORDINANCE OF THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA, TO DETACH CERTAIN LANDS AND REAL ESTATE NOW LYING WITHIN THE CITY LIMITS FROM THE CITY LIMITS AND DESIGNATING EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELLEVUE, SARPY COUNTY, NEBRASKA:

Section 1. Whereas, the owners of the land situated within and adjacent to the corporate limits of the City of Bellevue and more particularly described as follows:

Located within the Northwest one-quarter of Section 27, Township 14 North, Range 13 East of the 6th P.M., Sarpy County, Nebraska commencing at the point of intersection of the south right-of-way line of Thurston Avenue and the east right-of-way line of 15th Street; thence, North 89 degrees 10' 40" East assumed bearing a distance of 1163.28 feet along the South right-of-way line of Thurston Avenue to the point of beginning. Thence continuing North 89 degrees 10' 40" East a distance of 320 feet. Thence South 00 degrees 49' 20" East a distance of 638.46 feet. Thence South 89 degrees 37' 27" West a distance of 320.01 feet. Thence North 00 degrees 49' 20" West a distance of 635.97 feet to the point of beginning.
