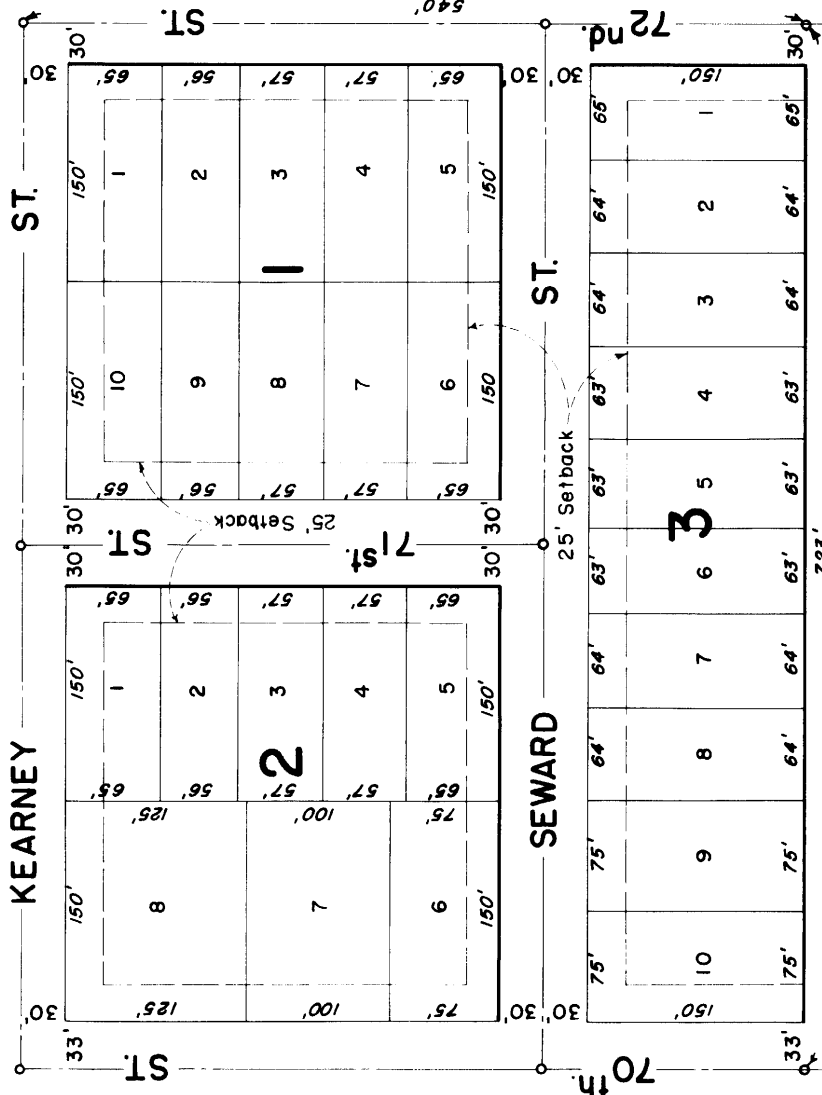


# BARNHILL ACRES LINCOLN, NEBRASKA
