PAUL RAILROAD COMPANY" its successors and assigns, the right o^r way and the right to construct, maintain and operate standard railroad track with a clearance o^r not less than eight and one half (8 $\frac{1}{2}$) feet on each side o^r the center line o^r said railroad track for all buildings except grain elevators, which side the clearance shall be ten and one-half (10 $\frac{1}{2}$) feet from the center line o^r said track over land across this part o^r the northwest quarter (NW $\frac{1}{4}$) o^r the southeast quarter (SE $\frac{1}{4}$) in the northeast quarter (NE $\frac{1}{4}$) o^r the southwest quarter (SW $\frac{1}{4}$) o^r section twenty-nine (29) Township thirteen (13) north, Range ten (10) east in Sarpy County, Nebraska lying on the northwesterly side o^r the right o^r way o^r the railroad o^r said railroad company as shown in blue print map No. 1251-07 identified by the signature o^r F. T. Darton, attached hereto and made a part o^r this instrument.

DO HAVE AND HOLD the same unto the said railroad company, its successors and assigns, so long as said railroad track shall be operated.

The said Grantor, the LIMA-RICHIE COMPANY, has caused these presents to be sealed with its corporate seal and to be signed by its President and attested by its Secretary, this 21st day of November, A. D. 1881.
