LICENSE

KNOW ALL MEN BY THESE PRESENTS:

COMPARED

That the BEAVER LAKE CORPORATION, a corporation organized and existing by virtue of the laws of the State of Nebraska, hereinafter referred to as the "Grantor", its lessees, successors and assigns, in consideration of One Dollar and other valuable consideration to it paid, receipt whereof is hereby acknowledged, does hereby grant, convey, sell, assign, transfer, and set over unto the OMAHA PUBLIC POWER DISTRICT, a public corporation, organized and existing by virtue of the laws of the State of Nebraska, hereinafter referred to as the "Licensee", its lessees, successors and assigns, a perpetual, non-exclusive license in common with other utilities, holding a similar license, permitting the Licensee to exercise certain rights, privileges, authority and right-of-way, as hereinafter more specifically set forth, under, upon, along and above the following described easement, to-wit:

15 feet wide along both sides of all road rights of way; and 10 feet wide along the side and rear lines of each lot, together with the right to ingress and egress. The person owning more than one lot may build on any such lot line and the easement shall be inoperative as to said line provided that such building shall be placed thereon prior to the instigation of use of this easement.

reserved in each and every lot contained in the legal description attached hereto and by this reference made a part hereof. The above easement arises by virtue of the protective covenants, restructions and easements of record recorded in Book D Pages 195 and 196 in the records of the Office of the Register of Deeds of Cana County, Nebraska, incorporated into and made a part of

and thereby encumbering each and every deed conveying each and every lot contained in the above described realty. This license shall run with the easement which in turn runs with the land.

More specifically, the Grantor grants, conveys, sells, assigns and transfers the following perpetual non-exclusive rights in common with other utilities holding similar rights, in the above described easements to the Licensee, to-wit:

- and egress across the Grantor's easement for any purpose necessary in connection with the survey, construction, relocation, inspection, repair, replacement, addition to, maintenance, operation and removal of power lines. Such ingress and egress shall be exercised in a reasonable manner.
- remove all trees and brush on said right-of-way as may be necessary to efficiently survey, construct, reconstruct, relocate, inspect, repair, replace, add to, maintain, operate and remove said lines, together with the express provision that any and all trees which, in falling, would come within 15 feet of the nearest electric line conductor, may be topped or removed. All refuse from such cutting or trimming shall be removed by the Licensee.
- to relocate or add additional electric transmission lines consisting of poles, towers, tower foundations, down-guys, anchors, cross-arms, insulators, wires, supports and other fixtures and equipment, with changed dimensions and different voltages, over, above, along, under, in and across the above described real estate covered by the easement.
