EASEMENT AND RIGHT OF WAY

THIS INDENTURE, made this April day of April , 1980, between Arlyne Geschwender and Leonard Geschwender, wife and husband, hereinafter referred to as "Grantors", and Metropolitan Utilities District of Omaha, a Municipal Corporation, hereinafter referred to as "Grantee", WITNESSETH:

That Grantors, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, do hereby grant to Metropolitan Utilities District of Omaha, its successors and assigns, an easement and right of way to lay, maintain, operate, repair, relay and remove, at any time, pipelines for the transportation of gas and water, and all appurtenances thereto, together with the right of ingress and egress to and from the same, on, over, under and through lands described as follows:

Several tracts of land lying in Lots, 1, 2, 4, 5, 6, 7, 8 and 9 located in Birch Tree Lofts, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska, the same being a replatting of part of Lot Six (6), Pierson's Subdivision, an Addition as surveyed, platted and recorded in Douglas County, Nebraska. Said tracts of land are more particularly described as follows:

The Northerly Ten (10) feet of Lots One (1) and Two (2);

The Northerly Fifteen (15) feet of Lots Five (5), Six (6), Seven (7) and Eight (8);

The Westerly Forty-five (45) feet of the Southerly Six (6) feet of Lot Eight (8);

The Westerly Ten (10) feet of Lot Eight (8);

The Southerly Two (2) feet of Lot Seven (7);

The Westerly Ten (10) feet of Lot Four (4);

All of Lot Nine (9).

Said tracts of land, as shown on the plat attached hereto and made a part hereof by this reference, contain Sixty-two Hundredths (0.62) acre, more or less.

TO HAVE AND TO HOLD said easement and right of way unto the said Grantee, Metropolitan Utilities District of Omaha, its successors and assigns.

- 1. Grantors agree that neither they nor their heirs or assigns will at any time erect, construct or place on or below the surface of said tracts of land any building or structure, except pavement, and that they will not give anyone else permission to do so.
- 2. Grantee shall restore the surface of the soil excavated for any purpose hereunder, as near as may be reasonably possible to the original contour thereof and as soon after such work is performed as may be reasonably possible to do so.
- 3. Nothing herein contained shall be construed as a waiver of any rights of Grantors, or duties and powers of Grantee, respecting the ownership, use, operations, extensions and connections to any pipeline constructed and maintained hereunder.
