

ORDINANCE NO. 621

AN ORDINANCE AMENDING TERRITORY TO THE CITY OF BELLEVUE, NEBRASKA, AND EXTENDING THE LIMITS OF THE SAID CITY, ACCORDINGLY, REPEALLING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH, AND DESIGNATING EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELLEVUE, NEBRASKA:

SECTION 1. THAT PURSUANT TO THE WRITTEN REQUEST OF ALL THE OWNERS OF THE PROPERTY HEREINAFTER DESCRIBED FOR ANNEXATION OF SAID PROPERTY AND TERRITORY TO THE CITY OF BELLEVUE, NEBRASKA, A PROPER PLAT THEREOF HAVING BEEN HERETOFORE FILED IN THE OFFICE OF THE CITY CLERK OF THE CITY OF BELLEVUE, NEBRASKA, ACCORDING TO LAW, THE FOLLOWING DESCRIBED LAND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF BELLEVUE, NEBRASKA, TO-WIT:

A PART OF THE NORTHEAST QUARTER OF SECTION 35 AND THE SOUTHWEST QUARTER OF SECTION 26, TOWNSHIP 14 NORTH, RANGE 15 EAST OF THE 6TH P.M., SARDY COUNTY, NEBRASKA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
COMMENCING AT THE NORTHEAST CORNER OF SAID SECTION 35; THENCE SOUTH 0°20'10" EAST (ASHBY'S BEARING) ALONG THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 35 A DISTANCE OF 153.45 FEET; THENCE SOUTH 88°57'05" WEST ALONG THE OLD CLAIM LINE A DISTANCE OF 764.71 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 89°57'08" WEST ALONG THE OLD CLAIM LINE A DISTANCE OF 575.84 FEET; THENCE NORTH 33°50'58" WEST ALONG THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY No. 151 A DISTANCE OF 687.82 FEET; THENCE NORTH 31°31'08" WEST ALONG THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY No. 131 A DISTANCE OF 509.37 FEET; THENCE NORTH 33°38'53" WEST ALONG THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY No. 151 A DISTANCE OF 589.39 FEET; THENCE SOUTH 89°44'38" EAST ALONG THE SOUTH RIGHT-OF-WAY LINE OF JEWELL AVENUE A DISTANCE OF 1275.95 FEET; THENCE SOUTH 65°51'48" EAST A DISTANCE OF 143.60 FEET; THENCE SOUTH 31°25'40" WEST A DISTANCE OF 189.34 FEET; THENCE NORTH 56°34'20" WEST A DISTANCE OF 10.12 FEET; THENCE SOUTH 31°25'40" WEST A DISTANCE OF 118.00 FEET; THENCE SOUTH 46°22'01" EAST A DISTANCE OF 56.77 FEET; THENCE SOUTH 3°01'07" EAST A DISTANCE OF 630.66 FEET; THENCE NORTH 3°03'16" EAST A DISTANCE OF 278.00 FEET; THENCE SOUTH 80°02'21" WEST A DISTANCE OF 186.94 FEET; THENCE SOUTH 07°09'29" WEST A DISTANCE OF 162.83 FEET; THENCE SOUTH 82°50'31" EAST A DISTANCE OF 10.0 FEET; THENCE SOUTH 07°09'29" WEST A DISTANCE OF 243.32 FEET TO THE POINT OF BEGINNING

IS HEREBY DECLARED TO BE AND IS HEREBY ANNEXED TO THE CITY OF

BELLEVUE, NEBRASKA, AS BROADWAY, AND THE LIMITS OF THE CITY OF BELLEVUE, NEBRASKA, ARE HEREBY EXTENDED ACCORDINGLY AND SAID LANDS AND THE PERSONS RESIDING THEREON SHALL HEREAFTER HAVE ALL PRIVILEGES AND BENEFITS AND BE SUBJECT TO ALL OF THE RULES, REGULATIONS, ORDINANCES, TAXES AND ALL OTHER BURDENS AND BENEFITS OF OTHER PERSONS AND TERRITORY INCLUDED WITHIN THE CITY OF BELLEVUE, NEBRASKA.

SECTION 2. ALL STREETS, AVENUES, ALLEYS, PUBLIC GROUNDS AND RIGHT-OF-WAYS ARE HEREBY ACCEPTED AS DESIGNATED AND AS SHOWN ON THE PLAN OF SAID SUBDIVISION.

SECTION 3. THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL FORCE FROM AND AFTER ITS PASSAGE, APPROVAL AND PUBLICATION ACCORDING TO LAW, AND ALL ORDINANCES IN CONFLICT HEREWITH ARE REPEALED.

**ORDINANCE NO. 81**  
**AN ORDINANCE ANNEXING**

**BE IT ORDAINED BY THE MA-**  
**JOR AND COUNCIL OF THE**  
**CITY OF BELLEVUE, NE-**  
**BRASKA:**

Section 1.  
That pursuant to the written request of all the owners of the property hereinafter described for annexation of said property and territory to the City of Bellevue, Nebraska, a proper plat thereof having been heretofore filed in the Office of the City Clerk of the City of Bellevue, Nebraska, according to law, the following described land contiguous to the corporate limits of the City of Bellevue, Nebraska, to-wit:  
A part of the Northeast Quarter of Section 36 and the Southeast Quarter of Section 26; Township 14 North, Range 13 East of the 6th P.M. Sarny County, Nebraska, more particularly described as follows: Commencing at the Northeast corner of said Section 33; thence South 0°20'33" East (assumed bearing) along the East line of said Northeast Quarter of said Section 26 a distance of 153.45 feet; thence South 89°57'06" West along the old claim line a distance of 764.71 feet to the point of beginning; thence continuing South 89°57'06" West along the old claim line a distance of 576.24 feet; thence North 33°50'28" West along the Eastern right-of-way line of State Highway No. 265, a distance of 687.22 feet; thence

North 21°25'08" West along the Eastern right-of-way line of State Highway No. 131 a distance of 500.37 feet; thence North 23°38'53" West along the Eastern right-of-way line of State Highway No. 131 a distance of 588.86 feet; thence South 89°44'38" East along the South right-of-way line of Jewell Avenue a distance of 1,776.85 feet; thence South 65°51'49" East a distance of 143.60 feet; thence South 31°25'59" West a distance of 189.34 feet; thence North 56°34'20" West a distance of 10.12 feet; thence South 31°25'49" West a distance of 118.00 feet; thence South 46°22'01" East a distance of 56.77 feet; thence South 34°01'07" East a distance of 620.98 feet; thence South 30°54'16" East a distance of 272.00 feet; thence North 89°02'21" West a distance of 186.84 feet; thence South 07°08'25" West a distance of 162.23 feet; thence South 62°50'31" East a distance of 30.00 feet; thence South 07°08'25" West a distance of 303.24 feet to the point of beginning.

is hereby declared to be and is hereby annexed to the City of Bellevue, Nebraska, as hereinafter stated, and the limits of the City of Bellevue, Nebraska, are hereby extended accordingly and said lands and the persons residing thereon, shall hereafter have all privileges and benefits and be subject to all of the rules, regulations, ordinances, taxes and all other burdens and benefits of other persons and territory included within the City of Bellevue, Nebraska.

All streets, avenues, alleys, public grounds and right-of-ways are hereby accepted as dedicated and as shown in the plat of said Subdivision South 26.

This ordinance shall take effect and be in full force from and after its passage, approval and publication according to law and all ordinances, in conflict herewith are repealed.


