AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS AND RESTRICTIONS

The undersigned, being owners of two-thirds of the lots within Bishop Square, an addition to Lincoln, Lancaster County, Nebraska, do hereby further amend the Declaration of Protective Covenants, Conditions and Restrictions, dated April 5, 1974 and recorded as Instrument No. 74-5536, Register of Deeds, Lancaster County, Nebraska ("the Declaration"), and the Amendments thereto dated, respectively, January 18, 1979, May 15, 1981, April 27, 1993, and July 3, 2001, recorded as Instrument Nos. 79-4188, 81-10294, 94-47236, and 2001-045299 as follows:

- 1. Sections II and X of the Declaration, as heretofore amended, are hereby stricken in their entirety and the following sections inserted in lieu thereof:
 - II. No lot or any building within the Properties shall be used other than for residential purposes. The owner of a building within the Properties shall be the primary or one of the primary occupants thereof, except as provided below. No owner of a building within the Properties may lease a building or any portion of a building within the Properties without submitting the Lease and Lessor information to the Board of Directors for their approval or disapproval. The Lease agreement may not be longer than a one-year term, it must contain language acknowledging the Board of Directors' right to cancel lessee's tenancy for cause upon the giving of thirty days written notice, and any extension of the Lease must be reviewed by the Board of Directors. A building within the Properties may not be occupied by approved non-owners for a period longer than three years.
 - X. No boats, campers, trailers, recreational vehicles, commercial tractor trailers, or oversized commercial vehicles of any variety shall be stored or parked in front of or on any lot within the Properties, except within an enclosed structure. No automobile or other motor vehicle may be stored or parked on the streets within the Properties for a continuous period of longer than seven days. Vehicles may be temporarily parked along the sides of the streets within the Properties. Owners are to keep automobiles and motor vehicles in their garage and must report vehicles expected to be using street parking regularly to the Board of Directors.
- 2. The Declaration, as heretofore and herein above amended, is hereby ratified and confirmed.
