



AMENDMENT TO RESTATED AND AMENDED MASTER DEED AND DECLARATION FOR BLOOMFIELD TOWNHOMES, A CONDOMINIUM PROPERTY REGIME

THIS AMENDMENT TO RESTATED AND AMENDED MASTER DEED AND DECLARATION FOR BLOOMFIELD TOWNHOMES, A CONDOMINIUM PROPERTY REGIME (the "Regime"), is executed this $\begin{array}{c} \mathcal{U} & \text{th} \\ \mathcal{U} & \text{th} \end{array}$ day of $\begin{array}{c} \mathcal{M} & \mathcal{A} & \mathcal{Y} \\ \mathcal{M} & \text{th} \end{array}$, 1992, by and among the undersigned, constituting not less than a 75% majority in interest in said condominium property regime.

WITNESSETH:

WHEREAS, the Restated and Amended Master Deed and Declaration for the Regime was executed on the 11th day of December, 1987, and recorded in Miscellaneous Record Book 835, at Page 498, in the Office of the Register of Deeds of Douglas County, Nebraska, on December 28, 1987; and

WHEREAS, said Restated and Amended Master Deed and Declaration (i) includes, within the legal description of the Regime, two surplus parcels of land, the first surplus parcel being a portion of an Easement granted by the Regime to Central States Health & Life Co. of Omaha for an exercise path, which Easement is dated October 14, 1983, and was recorded November 7, 1983, in Miscellaneous Record Book 699, at Page 602, in the Office of the Register of Deeds of Douglas County, Nebraska, and the second surplus parcel being located beyond the East boundary fence of the Regime, contiguous to other property owned by Central States Health & Life Co. of Omaha, both of which should be deleted from the Regime, and (ii) contains an incomplete description in Article II of the "property submitted" to the Regime, by failing to include certain property located between the East fenced-in boundary of the Regime adjacent to portions of the Easterly lines of Lots Sixteen (16) and Seventeen (17), Bloomfield Townhomes.

NOW, THEREFORE, said Restated and Amended Master Deed and Declaration is hereby amended as follows:

1. The following two surplus parcels of land are hereby deleted from the legal description of the property constituting a portion of Bloomfield Townhomes:

PARCEL 1

That part of the Southeast Quarter of the Northeast Quarter of Section 16, Township 15 North, Range 12 East

of the 6th P.M., Douglas County, Nebraska, described as follows:

Commencing at the point of intersection of the West line of 96th Street and the North line of Nicholas Street, said point being 33.00 feet West of the East line of said Section 16 and 330.00 feet South of the South line of the Northeast Quarter of said Section 16;

thence West (assuming the East line of said Section 16 to bear North and South) 435.60 feet on the North line of Nicholas Street;

thence North 510.00 feet on a line 468.60 feet West of and parallel from the East line of said Section 16 to the Southeast corner of Bloomfield Townhomes Property Regime as described on a Master Deed Recorded in Deed Book 1713 at Page 219 of the Douglas County Records and hereinafter called Tract "A";

thence continuing North 490.09 feet on the East line of said Tract "A";

thence North 89°58'33" East 50.72 feet on the East line of said Tract "A" to the Point of Beginning;

thence continuing North 89°58'33" East, 29.28 feet on the East line of said Tract "A";

thence North 29.10 feet on the East line of said Tract "A";

thence South 45°09'37" West 41.29 feet to the Point of Beginning (containing 426 square feet more or less).

PARCEL 2

That part of the Southeast Quarter of the Northeast Quarter of Section 16, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Commencing at the point of intersection of the West line of 96th Street and the North line of Nicholas Street, said point being 33.00 feet West of the East line of said Section 16 and 330.00 feet South of the South

line of the Northeast Quarter of said Section 16:

thence West (assuming the East line of said Section 16 to bear North and South) 435.60 feet on the North line of Nicholas Street;

thence North 510.00 feet on a line 468.60 feet West of and parallel from the East line of said Section 16 to the Southeast corner of Bloomfield Townhomes Property Regime as described on a Master Deed Recorded in Deed Book 1713 at Page 219 of the Douglas County Records and hereinafter called Tract "A";

thence continuing North 205.67 feet on the East line of said Tract "A" to the Point of Beginning;

thence North 04°31'16" West 91.24 feet;

thence North 02°52'42" East 143.22 feet to the East line of said Tract "A";

thence South 234.00 feet to the Point of Beginning (Containing 841 square feet more or less).

2. The following parcel of land located between the East fenced-in boundary of the Regime and the East adjacent to portions of Lots Sixteen (16) and Seventeen (17), Bloomfield Townhomes, is hereby added to the legal description of the property constituting Bloomfield Townhomes:

PARCEL 3

That part of the Southeast Quarter of the Northeast Quarter of Section 16, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Commencing at the point of intersection of the West line of 96th Street and the North line of Nicholas Street, said point being 33.00 feet West of the East line of said Section 16 and 330.00 feet South of the South line of the Northeast Quarter of said Section 16:

thence West (assuming the East line of said Section 16 to bear North and South) 435.60 feet on the North line of Nicholas Street;

thence North 510.00 feet on a line 468.60 feet West of and parallel from the East line of said Section 16 to the Southeast corner of Bloomfield Townhomes Property Regime as described on a Master Deed Recorded in Deed Book 1713 at Page 219 of the Douglas County Records and hereinafter called Tract "A";

thence continuing North 439.67 feet on the East line of said Tract "A" to the Point of Beginning;

thence continuing North 8.44 feet on the East line of said Tract "A" to a point on the Southeasterly line of a tract of land described in Deed Book 1819 at Page 430 of the Douglas County Records and hereinafter called Parcel 17;

thence North 38°38'28" East 29.18 feet on the Southeasterly line of said Parcel 17 to the most Southerly corner of a tract of land described in Deed Book 1819 at Page 437 of the Douglas County Records and hereinafter called Parcel 16;

thence continuing North 38°38'28" East 24.61 feet on the Southeasterly line of said Parcel 16 to the East line of said Tract "A";

thence North 89°58'33" East 17.13 feet on the East line of said Tract "A";

thence South 45°09'37" West 71.54 feet to the Point of Beginning.

3. Except as amended herein, all of the terms, conditions and provisions of the Restated and Amended Master Deed and Declaration for Bloomfield Townhomes are hereby ratified and shall remain in full force and effect.

IN WITNESS WHEREOF, each of the undersigned owners of the condominium units ("Lots") listed below, each such owner having an undivided 4.166666% interest in the Common Elements of the Regime and 4.166666% of the Regime votes, has executed this Amendment as of the date first set forth above and further authorizes the President and Secretary of Bloomfield Townhomes, Inc. to execute, deliver and accept such deeds and other transfer instruments as such officers shall approve to effectuate the foregoing Amendment, in such form as such officers shall approve.


