ORDINANCE TO ANNEX TERRITORY

WHEREAS MEADOWDALE ADDITION; METHODIST CHURCH ADDITION; and BUENA VISTA ADDITION; all contiguous and adjacent to the Village of Waverly, Nebraska, have heretofore, by the act, authority and acquiescence of the owners thereof, been platted in accordance with Section 17-415, Revised Statutes of Nebraska, under the supervision of a licensed surveyor, and the streets thereon dedicated to the public, and whereas said plats have been accepted by the Board of Trustees of the Village of Waverly, and have been recorded in the office of the Register of Deeds of Lancaster County, and whereas said real estate will receive material benefits and advantages from annexation to said Village;

NOW THEREFORE BE IT ORDAINED BY THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF WAVERLY, NEBRASKA:

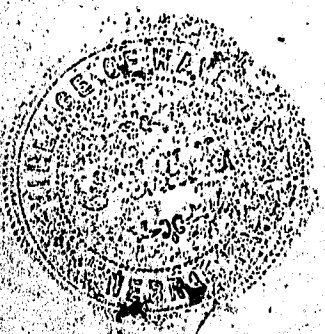
That the Additions hereinbefore described, as platted, replatted, dedicated, accepted and recorded, be and the same is hereby included within the boundaries and territory of the Village of Waverly, Nebraska and said lands and the persons residing thereon shall hereafter be subject to all the rules, regulations, ordinances, taxes, and all other burdens and benefits of other persons and territory included within the Village of Waverly, Nebraska.

Done by and under the authority of Section 17-405 through 17-413 of the Revised Statutes of Nebraska. This Ordinance shall take effect and be in force from and after its passage and shall be posted as required by law.
