ASSIGNMENT AND ASSUMPTION OF DECLARANT RIGHTS PURSUANT TO THE SECOND AMENDED AND RESTATED DECLARATION OF COVENANTS CONDITIONS, RESTRICTIONS AND EASEMENTS OF Lots 1 through 107, inclusive, CENTENNIAL, A SUBDIVISION IN DOUGLAS COUNTY, NEBRASKA

This Assignment and Assumption of Declarant Rights is entered into by and between Spence Title Services, Inc., Trustee, as successor Declarant ("Assignor") and Centennial Homeowners Association, a Nebraska nonprofit corporation ("Assignee").

WHEREAS, Assignor is the Declarant under that certain Second Amended and Restated Declaration of Covenants, Conditions, Restrictions and Easements of Lots 1 through 107, Centennial, which was recorded in the office of the Douglas County Register of Deeds on November 14, 2003, Instrument No. 2003222333, against the following described real property, to-wit:

Lots 1 through 107, inclusive, Centennial, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska (hereinafter referred to as the "Declaration").

WHEREAS, Assignor agrees to assign and Assignee agrees to assume Assignor's rights, obligations and duties under the Declaration.

NOW, THEREFORE, the parties agree:

- 1. Assignor hereby assigns to Assignee all of its rights, obligations and duties as Declarant under the Declaration. This instrument shall also serve as the Notice of Termination of Status as Declarant pursuant to Section 3 of Article IV of the Declaration.
- 2. Assignee hereby assumes all of Assignor's rights, obligations and duties as Declarant under the Declaration.
 - 3. Accordingly, Assignee is hereby the Declarant under the Declaration effective immediately.
