W I T N E S S E T H

1. Purpose. The purpose of this Second Amendment to the Amended Master Deed and Declaration is to bring the said Amended Master Deed and Declaration into compliance with all requirements, regulations, and policies of the U.S. Department of Housing and Urban Development and the Federal Housing Commissioner so that all units within the Cimarron Condominium are eligible for mortgage insurance through the Federal Housing Administration.

2. Legal Description. The legal description of the real property which comprises the condominium regime is more particularly described as:

Lots 1 and 2, Cimarron, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.

3. A . The following paragraph is to be added to said Amended Master Deed and Declaration:

12. FHA/HUD REQUIREMENTS

All requirements of the U.S. Department of Housing and Urban Development/Federal Housing Commissioner set forth in Appendix 24 to HUD Handbook 4265.1 CHG4 are incorporated herein by this reference and said HUD/FHA requirements shall prevail in the event of any inconsistency with any other terms contained in this Amended Master Deed and Declaration.
