## AMENDMENT TO PROTECTIVE COVENANTS

Paragraph 23 of the Protective Covenants provides that said Covenants may be amended by the Developer for a period of ten (10) years following July 16, 1991 by executing and recording one or more duly acknowledged Amendments to Protective Covenants in the Office of the Register of Deeds of Douglas County, Nebraska.

NOW, THEREFORE, Developer hereby declares that the Protective Covenants recorded on July 16, 1991 in Book 971 at Page 246 for the following described lots, to-wit:

Lots 1-120, THE COLONIES REPLAT II, a subdivision as surveyed, platted and recorded

should be and hereby are amended by:

- 1. Deleting from Paragraph 6. <u>Area</u>. "ground floor" and "main floor" and the parentheses around "above grade".
- 2. Changing the heading of paragraph 11. from "Signs". to "Signs/Model Homes". and adding the following as the final sentence to said paragraph 11. "Model homes may be maintained by the Developer notwithstanding the fact there are no longer any vacant lots within the subdivision for sale."

All other terms of said Protective Covenants shall remain in full force and effect.
