AGREEMENT

THIS AGREEMENT made and entered into this 28 day of September, 1970, by and between IRVIN GENDLER, NATALIE GENDLER, H. LEE GENDLER, and CAROL GENDLER, hereinafter referred to as "Gendler", and FRANK B. CERNIK, hereinafter referred to as "Cernik",

WITNESSETH:

WHEREAS, Gendler and Cernik own separate parcels of real estate located within the Northeast quarter of the Northeast quarter, Section 33, Township 16 North, Range 12, East of the 6th P.M., Douglas County, Nebraska, which parcels of real estate are shown on the plat attached hereto, marked "Exhibit A" and incorporated herein by reference, which plat refers to Tract A and Tract E, said Tract A being owned by Cernik and said Tract E being owned by Gendler.

NOW, THEREFORE, it is agreed by and between the parties hereto as follows:

- 1. No building shall be constructed West of the East 150 feet of Tract A, without the prior written consent of the owner of Tract E, which consent shall not be unreasonably withheld.
- 2. No building shall be constructed on Tract E. The owner of Tract E may erect a sign on said Tract, the bottom of which shall be higher than the top of the highest building constructed on the East 150 feet of Tract A.
- 3. The covenants herein contained are superior and paramount to any of the rights of the parties hereto in the respective tracts. This Agreement shall be construed as a covenant running with the land.
- 4. This Agreement shall be binding upon the heirs, successors and assigns of the parties hereto.
