The West One-half (W1/2) of Southeast Quarter of Southeast Quarter (SE1/4, SE1/4) of Section Nineteen (19); all of the Northwest Quarter of the Northeast Quarter (NW1/4,NE1/4) Section Thirty (30) and the triangular plot lying North and West of the Road in the Southwest Quarter of the Northwest Quarter (SW1/4,NE1/4) of Section Thirty (30), all in Town-ship Sixteen (16) North, Range Thirteen (13), East of the 6th P.M., Douglas County, Nebraska,

said easement between Omaha Home for Boys and Omaha Public Power District, dated September 14, 1956.




