The undersigned does hereby acknowledge and declare that any right or interest that it may have or claim to have upon the real property described in Exhibit A under and by virtue of the subordinated lease shall be and remain at all times subject, junior and inferior to the Deeds of Trusts and that the Deeds of Trusts shall be at all times a prior, superior, and paramount liens upon the above-described real estate, over any interest of the undersigned **B & B Trucking**, **Inc.**
