hereinafter known as the Grantor, whether one or more, for and in consideration of the sum of SIX HUNDRED SIXTY AND NO/100--(\$660.00)--DOLLARS in hand paid does hereby grant and convey unto THE STATE OF NEBRASKA, DEPARTMENT OF ROADS, and to its successors and assigns the following described permanent easement for the purpose of UTILITIES and the subsequent maintenance of same, situated in DOUGLAS County, and State of Nebraska, to-wit;

A TRACT OF LAND FOR UTILITIES PURPOSES LOCATED IN LOTS 15-16, WEST "L" STREET ACRES ANNEX, OF THE CITY OF OMAHA, DOUGLAS COUNTY, NEBRASKA, DESCRIBED AS FOLLOWS:

REFERRING TO THE POINT WHERE THE SOUTHERLY EXISTING RIGHT OF WAY LINE OF "L" STREET INTERSECTS THE WESTERLY EXISTING RIGHT OF WAY LINE OF 46TH AVENUE; THENCE SOUTHERLY A DISTANCE OF 14.91 FEET ALONG THE WESTERLY EXISTING 46TH AVENUE RIGHT OF WAY LINE; THENCE NORTHWESTERLY DEFLECTING 112 DEGREES, 02 MINUTES, 52 SECONDS RIGHT, A DISTANCE OF 20.91 FEET; THENCE WESTERLY DEFLECTING 025 DEGREES, 29 MINUTES, 16 SECONDS LEFT, A DISTANCE OF 55.00 FEET TO THE POINT OF BEGINNING; THENCE WESTERLY DEFLECTING 000 DEGREES, 00 MINUTES, 00 SECONDS A DISTANCE OF 40.00 FEET; THENCE NORTHERLY DEFLECTING 090 DEGREES, 00 MINUTES, 00 SECONDS RIGHT, A DISTANCE OF 3.00 FEET; THENCE EASTERLY DEFLECTING 090 DEGREES, 00 MINUTES, 00 SECONDS RIGHT, A DISTANCE OF 40.00 FEET; THENCE SOUTHERLY DEFLECTING 090 DEGREES, 00 MINUTES, 00 SECONDS RIGHT, A DISTANCE OF 3.00 FEET TO THE POINT OF BEGINNING CONTAINING 120.00 SQUARE FEET, MORE OR LESS.

The abandonment of said permanent easement for the purposes described herein shall render this conveyance void and cause said permanent easement to revert to said Grantor and to his, her or their heirs, successors and assigns.
