

<u>LEGAL DESCRIPTION</u> - EASEMENT RELEASE NORTH PARK 1st ADDITION - BOOK 1792, PAGE 499 AND NORTH PARK REPLAT I - BOOK 1824, PAGE 130

An Existing Omaha Public Power District, Northwestern Bell Telephone Company and Cable Television System Easement to be Released located in Lots 1 and 2, North Park Replat Two, a subdivision located in the West 1/2 of the SW 1/4 of Section 8, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, more particularly described as follows:

Commencing at the Southwest corner of Lot 3, North Park Replat I, a subdivision located in said West 1/2 of the SW 1/4 of Section 8, said point also being the Northwest corner of Outlot "A", said North Park Replat Two, said point also being on the East line of said Lot 1, North Park Replat Two; thence S89°58'19"W (assumed bearing), a distance of 8.00 feet to the point of beginning; thence continuing S89°58'19"W, a distance of 248.00 feet; thence N00°00'00"E, a distance of 123.00 feet; thence S89°58'19"W, a distance of 141.97 feet; thence N00°00'00"E, a distance of 16.00 feet; thence N89°58'19"E, a distance of 157.97 feet; thence S00°00'00"W, a distance of 131.00 feet; thence N89°58'19"E, a distance of 8.00 feet to the point of beginning.

Said Existing Omaha Public Power District, Northwestern Bell Telephone Company and Cable Television System Easement to be Released contains an area of 6,352 square feet or 0.146 acres, more or less.
