SIGN EASEMENT

For One Dollar (\$1.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned, NP 2 Limited Partnership, a Nebraska limited partnership, and its successors and assigns, (hereinafter "Grantor"), the fee simple owner of Lot 2 ("Lot 2") of North Park Replat I, a subdivision, as surveyed, platted and recorded in Douglas County, Nebraska, hereby grants to all present and future owners of Lot 1 ("Lot 1") of said North Park Replat I, (hereinafter collectively "Grantee"), for so long as each Grantee remains an owner thereof, a perpetual easement, for the purposes and subject to the terms and conditions hereinafter set forth, over and upon a portion of that part of Lot 2 which is west of Lot 1 and which is more particularly identified on the attached Exhibit "A", incorporated by this reference:

- 1. The easement area shall be used by Grantee only for the purpose of installing, maintaining, repairing and/or replacing a sign, not to exceed two feet in width above ground, four feet in height and ten feet in length. Grantee may reasonably install conduit and electrical wire in the easement area from a source located on Lot 1 to provide underground electrical power transmission to the sign for the purpose of illuminating the sign.
- 2. Such sign shall be solely for the purposes of advertising any lawful business being conducted on said Lot 1, and providing direction to such Lot 1. Prior to the installation or replacement of such sign, the exact location, design, material and manner of illumination of such sign shall be first approved by Grantor, for the purpose of assuring that such sign is properly located and consistent in quality with other signs located in the North Park Replat I, which consent will not be unreasonably withheld. After installation, the location of the easement shall be permanently fixed and defined as an area centered on the sign and not exceeding 350 square feet plus a ten-foot wide power transmission easement running between the sign and Lot 1. Grantee will maintain said sign in good order and repair.
- 3. Neither Grantor, nor any successor or assign of Grantor will install or maintain any sign on any portion of said Lot 2, North Park Replat I, which will result in the inability of Grantee to obtain the appropriate governmental permits to install, maintain, repair or replace grantee's sign, or which will result in the Grantee being unable to use the easement area for the purpose set forth herein. No signs, other than the sign permitted hereunder, shall be installed or maintained in the easement area, except any sign required by law.

- 4. Grantee accepts and assumes all liabilities, costs and risks arising from installation, removal, maintenance, replacement and existence of such sign, and agrees to indemnify and forever hold Grantor harmless therefor.
- 5. This sign easement, including all benefits and burdens, shall run with the land and shall be binding on the successors and assigns of the undersigned.
- 6. In the event such sign constructed and located upon the easement area of Lot 2 is not kept in good condition and repair, the owner of Lot 2 shall have authority but no duty to place such sign in good condition or repair and the owner of Lot 1 shall be liable for cost thereof, or, alternatively, all Grantee's rights hereunder shall terminate immediately unless needed repairs are completed within 45 days of written notice to Grantee of needed repair, which notice may be provided by the owner of Lot 2.

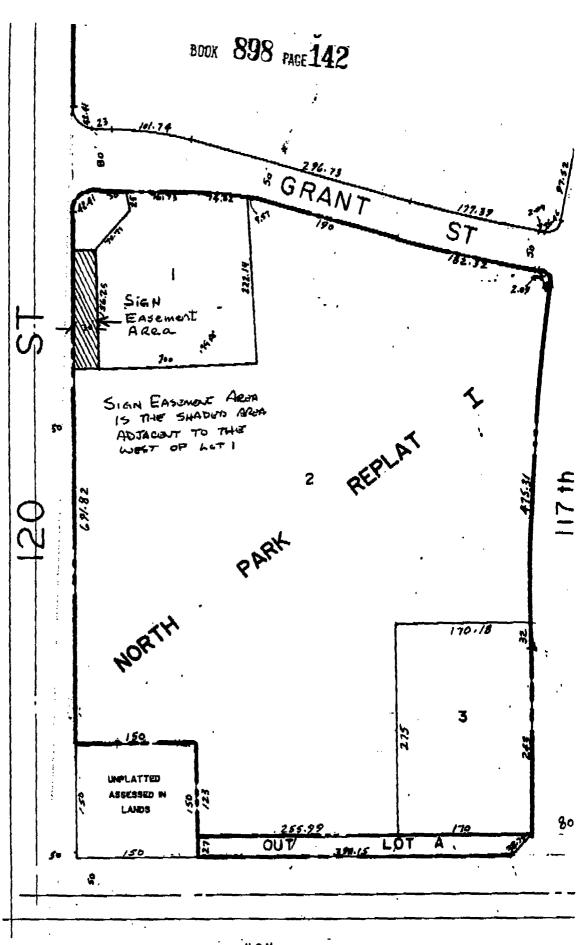
