RESOLUTION APPROVING ISSUANCE OF CERTIFICATE  
OF COMPLETION FOR 3801 LLC (Richard Eychaner)

WHEREAS, on July 25, 2011, by Roll Call 11-1326, the City Council approved an Urban Renewal Development Agreement with 3801 LLC (Richard Eychaner (the "Developer") for the redevelopment of 3801 Merle Hay Road, (herein collectively called the "Project"); and

WHEREAS, the Developer has completed the Project in substantial compliance with the approved Conceptual Development Plan and has requested the City issue a Certificate of Completion as evidence of satisfaction of the Developer's construction obligations under the Development Agreement; NOW THEREFORE,

BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The City Council hereby finds and acknowledges that Developer has satisfied its obligation to complete the Project described above in substantial compliance with the approved Conceptual Development Plan and the requirements of the Development Agreement. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 204 of the Development Agreement, for the improvements to 3801 Merle Hay Road, more specifically described as follows:


The West 50 feet of Lots 34 through 37, and except streets, Lots 43 through 54, Block P, Aviation Park, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. The City Clerk is hereby directed to cause a certified copy of the resolution and roll call to be recorded in the land records of the Polk County Recorder.




