MODIFICATION AND AMENDMENT OF EASEMENT GRANT

This instrument made and entered into this 25th day of February, 1966, by and between NORTHERN NATURAL GAS COMPANY, operating as Peoples Natural Gas Division, a Delaware corporation, (hereinafter referred to as "Peoples") and EDWARD WESTPHAL, JR. and SELMA F. WESTPHAL, husband and wife, and BERTHA WESTPHAL, widow, (hereinafter referred to as "Owners").

WITNESSETH THAT:

WHEREAS, Peoples is the holder of an Easement Grant covering the following described premises in Douglas County, Nebraska:

Northeast Quarter (NE/4) of Southeast Quarter (SE/4) and North Half (N/2) of Northwest Quarter (NW/4) of Southeast Quarter (SE/4) of Section 13, Township 15, Range 10

and

North Half (N/2) of Northwest Quarter (NW/4) of Southwest Quarter (SW/4) of Section 13, Township 15, Range 10

which Easement Grant has been recorded in Book 344 of Miscellaneous Records at Page 408 in the Office of the Register of Deeds for Douglas County, Nebraska; and

WHEREAS, pursuant to the authority contained in said Easement Grant, Peoples has constructed and currently operates and maintains a 4-inch pipeline through and across the premises above described; and

WHEREAS, of the premises described in said Easement Grant, Owners are present owners of the following described premises, hereinafter referred to as the "Owned Premises":

All of the property described above.

WHEREAS, the parties hereto desire to more clearly define their rights under such Easement Grant and further desire to modify and amend said Easement Grant in certain respects.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements hereinafter set forth, it is agreed by and between the parties hereto as follows:

1. That Peoples shall, and by these presents does, hereby limit its right-of-way under the aforescribed Easement Grant, to a strip of land 30 by 660 feet and described as the West 30 feet of the North 660 feet of the SE/4 of Section 13, Township 15 North, Range 10 East. A plat showing the location of said strip of land is attached hereto as Exhibit "A" and is, by this reference, made a part hereof.
2. That Peoples shall, and by these presents does, hereby release from its said Easement Grant all of the Owned Premises except the strip of land described in Paragraph 1 above, upon which strip said Easement Grant is retained as herein modified.
3. That Owners shall not build, create, construct, nor allow to be built, created or constructed, any hard surface road, building, or other structure, nor alter the grade or permit such alteration anywhere on the land upon which Peoples has reserved its Easement rights without the written consent of Peoples.

This instrument and the covenants and agreements herein contained shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
