SANITARY AND IMPROVEMENT DISTRICT NO. 25 OF SARPY COUNTY, NEBRASKA, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby assign, grant, sell and convey unto SANITARY AND IMPROVEMENT DISTRICT NO. 77 OF SARPY COUNTY, NEBRASKA, all of its right, title and interest in and to a perpetual easement for the operation and maintenance of a sanitary sewer line over and across the following described property, located in Sarpy County, Nebraska, to-wit:

An easement for installation and maintenance of an outfall sewer line five feet in width on either side of a line commencing 815 feet south and 33 feet west of the northeast corner of Section 9, Township 13 North, Range 13, East of the 6th P. M., Sarpy County, Nebraska, thence westerly a distance of 972 feet, thence northerly a distance of 130 feet, thence westerly a distance of 155 feet, thence northerly a distance of 690 feet, all in Sarpy County, Nebraska.

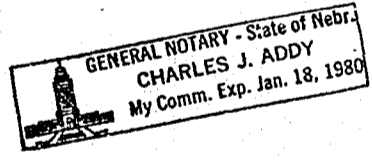

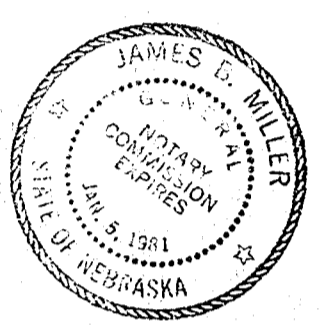
