## RELEASE OF EASEMENT

This Release of Easement is made this source day of of oroser, 2005, by SANITARY AND IMPROVEMENT DISTRICT NO. 423 OF DOUGLAS COUNTY, NEBRASKA, a Nebraska political subdivision (herein the "District"). A storm sewer easement (the "Easement") affecting Lot 3, The Thomsen Mile Replat Three and Lot 5, The Thomsen Mile Replat Two, subdivisions surveyed, platted and recorded in Douglas County, Nebraska (collectively the "Property" and individually a "Lot"), and are more particularly shown on Exhibits "A" thru "E", inclusive, attached hereto and incorporated herein by this reference, was granted to the District as set forth on the final plat of Thomsen Mile dated December 15, 2000 and recorded at Book 2198 Page 708 and as subsequently replatted. The Easement is hereby released as it pertains solely to the Property as set forth on Exhibits "A" thru "E". Any improvements located within the Easement are hereby abandoned by the District.


NOW, THEREFORE, in consideration of the above, and for other valuable consideration, the District hereby releases, discharges, rescinds and cancels all of its right, title and interest in the easement over Lot 3, The Thomsen Mile Replat Three and Lot 5, The Thomsen Mile Replat Two, subdivisions surveyed, platted and recorded in Douglas County, Nebraska.

In consideration of this Release, each owner of any Lot within the Property agrees to indemnify and hold harmless the District with respect to any abandoned storm sewer improvements installed within the Easement on an Owner's Lot as such abandoned storm sewer improvements may solely affect a respective owner's Lot.
