ASSIGNMENT OF FIRST AND LAST RIGHT OF REFUSAL AGREEMENT

This Assignment of First and Last Right of Refusal Agreement (this "Assignment") is made as of the day of 2013, by Value Investors Partnership, LLC, a Nebraska limited liability company ("Assignor"), to GRACE UNIVERSITY, a Nebraska non profit corporation ("Assignee"), and this Assignment is executed in connection with the following facts:

WHEREAS, Concurrently with the delivery of this Assignment, Assignor has conveyed to Assignee certain real property situated in Douglas County, Nebraska, located at 802 Worthington Street, Omaha, and legally described on **Exhibit "A"** attached hereto and incorporated herein by reference (the "**Property**"), pursuant to that certain Purchase Agreement dated as of <u>Movernice</u>, 2012, between Assignor as seller, and Assignee as purchaser (the "**Purchase Agreement**").

WHEREAS, Assignor holds certain rights under that certain First and Last Right of Refusal Agreement by and between Jean Marie Davidson, Trustee, and Andrew MacCashland ("MacCashland"), dated as of December 29, 2006, and recorded with the Douglas County Register of Deeds (the "Land Records") on January 3, 2007 as Document No. 2007001047, and as previously assigned to Assignor under that certain Assignment of First and Last Right of Refusal by and between MacCashland and Assignor dated as of 11/19/12, and recorded in the Land Records as Document No. 2013002579 (collectively, the "ROFR Agreement"), covering the property which is listed on Exhibit "B" attached hereto and incorporated herein by reference.

WHEREAS, in connection with the Purchase Agreement, Assignor desires to assign to Assignee all Assignor's rights and obligations under the ROFR Agreement.

NOW, THEREFORE, in consideration of the sale and purchase of the Property and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. <u>Assignment</u>. Assignor hereby assigns and transfers to Assignee all its rights and obligations under the ROFR Agreement.

- 2. <u>Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of the successors, assigns, personal representatives, heirs and legatees of the respective parties hereto.
- 3. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the State of Nebraska.
- 4. <u>Counterparts</u>. This Assignment may be executed in one or more counterparts which, when executed, shall constitute one Assignment.
- 5. WAIVER OF TRIAL BY JURY; VENUE. ASSIGNOR AND ASSIGNEE WAIVE ANY RIGHT TO TRIAL BY JURY OF ANY CLAIM ARISING UNDER OR IN CONNECTION WITH THIS AGREEMENT. ASSIGNOR AND ASSIGNEE AGREE THAT ANY SUCH CLAIM SHALL BE ADJUDICATED WITHOUT A JURY. EITHER PARTY MAY FILE AN ORIGINAL COUNTERPART OR A COPY OF THIS SECTION WITH ANY COURT AS WRITTEN EVIDENCE OF THE CONSENT OF THE OTHER PARTY TO THE WAIVER OF ITS RIGHT TO TRIAL BY JURY.

The parties agree that proper venue for any action arising under or in connection with this agreement shall be where the Property is located and any such action shall only be brought only in the state or federal court having jurisdiction in Douglas County, Nebraska.
