## SECOND AMENDMENT TO OPERATION AND EASEMENT AGREEMENT

WHEREAS, Kohl's and Developer are parties to that certain Operation and Easement Agreement dated March 11, 2005 and recorded May 24, 2005 at Roll 675, Image 2002, as Document No. 18989 with the Recorder of Woodbury County, Iowa, amended by that First Amendment to Operation and Easement Agreement dated June 30, 2006 and recorded September 15, 2006 at Roll 686, Image 6171-6180 as Document No. 4356 with the Recorder of Woodbury County, Iowa (collectively the "OEA") pursuant to which Kohl's and Developer agreed to certain terms and conditions relating to the development and operation of the Shopping Center, as defined in the OEA; and

WHEREAS, Kohl's and Developer desire to amend and clarify the permissible Building Areas referenced in Section 3.2 of the OEA; and

WHEREAS, Kohl's and Developer desire to amend the OEA as set forth herein.

NOW, THEREFORE, in consideration of the above premises and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. All terms contained herein with an initial capitalized letter which are not otherwise defined herein shall have the same meaning ascribed to them in the OEA.
- 2. Exhibit "X" to the OEA, "Site Plan", is hereby deleted and replaced with the attached Exhibit "X".
- 3. This Amendment is not intended to supersede or amend the OEA except as specifically set forth herein.
- 4. This Amendment will be void unless recorded with the Recorder of Woodbury County, lowa on or before June 30, 2007.
