## MEMORANDUM OF OPTION AND LEASE AGREEMENT

This Memorandum dated this and day of July, 1996, by and between Darrell J. Logemann and Coe Leta F. Logemann, RR 1, Box 1, Bennington, Nebraska 68007 (hereinafter "Lessor") and Omaha Cellular Telephone Company, c/o U S WEST NewVector Group, Inc., 3350 161st Avenue S.E., P.O.
