PARTIAL RELEASE OF EASEMENT

QWEST CORPORATION SPIRIT OF SERVICE, US WEST COMMUNICATIONS, INC., AND NORTHWESTERN BELL), whose principal place of business address is 1801 California St., Suite 900, Denver, CO 80202, hereinafter called the "Company", for and in consideration of \$__1.00__ and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby release that portion of easement on property described by virtue of the Plat and Dedications of Fort Crest Replat and Fort Crest Commercial Plaza, Subdivisions as surveyed, platted and recorded in Douglas County, Nebraska, over, upon, along and above the following described property:

A STRIP OF LAND TEN FEET (10') IN WIDTH, BEING FIVE FEET (5') EACH SIDE OF AND ABUTTING THE COMMON SIDE LOT LINES OF LOTS FOUR (4) AND FIVE (5), LOTS FIVE (5) AND EIGHT (8) OF SAID FORT CREST REPLAT, AND NOW KNOWN AS LOTS 2, 3, 5, 7 AND 9 IN FORT CREST COMMERCIAL PLAZA.

ALSO, A STRIP OF LAND TEN FEET (10') IN WIDTH BEING FIVE FEET (5') EACH SIDE AND ABUTTING THE COMMON SIDE LOT LINES OF LOTS THREE (3) AND FOUR (4), AND LOTS FOUR (4) AND FIVE (5), IN FORT CREST COMMERCIAL PLAZA.
