LEGAL DESCRIPTION

A TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 2, TOWNSHIP 14 NORTH, RANGE 12 EAST OF THE 6TH P.M. IN OMAHA, DOUGLAS COUNTY, NEBRASKA. SAID TRACT LIES IMMEDIATELY TO THE SOUTH AND ADJACENT TO THE PREVIOUSLY RECORDED TRACT KNOWN AS THE P.I.E. PROPERTY. THE BOUNDARIES OF SAID TRACT ARE DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 2 WHICH POINT IS ON THE CENTER LINE OF "F" STREET; THENCE SOUTH 0 DEGREES 17' EAST ALONG THE QUARTER SECTION LINE FOR A DISTANCE OF 805 FEET TO THE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE CONTINUING SOUTH 0 DEGREES 17' EAST ALONG THE QUARTER SECTION LINE FOR A DISTANCE OF 350 FEET; THENCE DUE EAST FOR A DISTANCE OF 1007.89 FEET TO A POINT ON THE WEST LINE OF 76TH STREET; THENCE NORTH 0 DEGREES 09' WEST ALONG WEST 1008.7 FEET TO THE POINT OF BEGINNING, EXCEPT THAT PART LOCATED IN THE SOUTHWEST CORNER TAKEN BY PAPIO-MISSOURI RIVER NATURAL RESOURCES
