

I HERESY CERTIFY: THAT I HAVE ACCURATELY SURVEYED AND STAKES WITH IRON PIPE ALL CORNERS OF ALL LOTS, STREETS, AVENUES, ANGLE POINTS (EXCEPT THOSE ANGLE POINTS FALLING ON THE LINE OF PAPILLION DRAINAGE DITCH WHICH ARE WET CORNERS) AND ENDS OF ALL CURVES ON THIS PLAT OF RAINBOW REPLAT AN ADDITION IN DOUGLAS COUNTY, NEBRASKA THAT GAID PLAT IS A PART OF THE NW 1/4 OF THE NE 1/4 AND A PART OF THE SW 1/4 OF THE NE 1/4 ALL IN SECTION 34, TWP. 15 NORTH, RANGE 12 EAST OF THE 6TH P M., ALL IN DOUGLAS COUNTY NEBRASKA, DESCRIBED AND BOUND AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTH LINE OF CENTER STREET ROAD WHICH POINT BEING 33 FEET SOUTH AND 271.99 FEET EAST OF THE NW COR. OF THE NE 1/4 OF SAID SECTION 34; THENCE EAST ALONG THE SOUTH LINE OF CENTER STREET TO A POINT ON THE EAST LINE OF THE NW 1/4 OF THE NE 1/4 OF SAID SECTION 34, A DISTANCE OF 1049.61 FEET: THENCE SOUTH ALONG THE EAST LINE OF THE WEST 1/2 OF THE NE 1/4 OF SAID SECTION 34 TO THE CENTER LINE OF PAPILLION DRAINAGE DITCH, A DISTANCE OF 1723.60 FEET: THENCE TURNING AN ANGLE OF 121° 51' 24" TO THE RIGHT AND RUNNING NORTHWESTERLY ALONG THE CENTER LINE OF PAPILLION DRAINAGE DITCH TO A POINT ON THE SOUTH LINE OF THE NW 1/4 OF THE NE 1/4 OF SAID SECTION 34. A DISTANCE OF 818.24 FEET; THENCE TURNING AN ANGLE OF 7° 48'37" TO THE RIGHT AND RUNNING NORTHWESTERLY ALONG THE CENTER LINE OF PAPILLION DRAINAGE DITCH. A DISTANCE OF 309.75 FEET; THENCE TURNING AN ANGLE OF 00 13'28" TO THE LEFT AND RUNNING ALONG THE CENTER LINE OF PAPILLION DRAINAGE DITCH, A DISTANCE OF 154.20 FEET: THENCE TUPNING ANGLE OF 92° 43'50" TO THE RIGHT AND RUNNING NORTHWESTERLY A DISTANCE 147469 FEET; THENCE TURNING ANGLE OF 42° 36'30" TO THE LEFT AND RUNNING NORTHERLY, A DISTANCE OF 96.25 FEET: THENCE TURNING ANGLE OF 2º 49' TO THE LEFT AND RUNNING NORTHERLY, A DISTANCE OF 100 FEET: THENCE TURNING AN ANGLE -CF 16° 13'30" TO THE LEFT AND RUNNING NORTHWESTERLY DISTANCE OF 52.90 FEET: THENCE TURNING AN ANGLE OF 10° II' TO THE RIGHT AND RUNNING NORTHERLY. A DISTANCE OF 151.56 FEET: THENCE TURNING AN ANGLE OF 3° 51' TO THE RIGHT AND RUNNING NORTHERLY TO POINT OF BEGINNING, A DISTANCE OF 486.40 FEET. 



