PERMITTED EXCEPTIONS

License and Easement granted to Northern Natural Gas Company (Peoples Natural Gas Division) by Agreement dated January 14, 1960 and recorded February 10, 1960, in Book 350 at Page 579 of the Miscellaneous Records of Douglas County, Nebraska, to construct, operate and maintain a gas pipe line and appurtenances across and under a portion of subject property.

Easement granted to Northern Natural Gas Company, operating as Peoples Natural Gas Division, by instrument dated September 6, 1961 and recorded October 10, 1961, in Book 370 at Page 661 of the Miscellaneous Records of Douglas County, Nebraska, to construct, operate and maintain a natural gas pipe line and appurtenances over and through a portion of subject property.

License and Easement granted to Northern Natural Gas Company (Peoples Natural Gas Division) by Agreement dated September 24, 1962 and recorded November 6, 1962, in Book 389 at Page 237 of the Miscellaneous Records of Douglas County, Nebraska, to construct, operate and maintain a gas pipe line and appurtenances across and under a portion of subject property.

The coal and iron and other minerals and mineral rights in and under and which may be produced from Parcel 3 were subsequently conveyed to Missouri Pacific Railroad Company, a Delaware corporation, by Quitclaim Deed dated September 28, 1995 and recorded December 29, 1995, in Book 2022 at Page 340 of the Deed Records of Douglas County, Nebraska.

Quitclaim Deed dated April 1, 1971 and recorded April 20, 1977, in Book 1567 at Page 307 of the Deed Records of Douglas County, Nebraska, wherein Union Pacific Railroad Company, a Utah corporation, conveys to Union Pacific Land Resources Corporation, a Utah corporation, all minerals and mineral rights in and under and which may be produced from Parcels 1 and 2.

Notice of Claim to Mineral Interest recorded March 4, 1993, in Book 2 at Page 17 of the Records of Douglas County, Nebraska, by Union Pacific Land Resources Corporation.

The minerals and mineral rights in and under and which may be produced from Parcels 1 and 2 were subsequently conveyed to Missouri Pacific Railroad Company, a Delaware corporation, by Quitclaim Deed dated September 28, 1995 and recorded December 29, 1995, in Book 2022 at Page 340 of the Deed Records of Douglas County, Nebraska.

Easement granted to the City of Omaha, Nebraska, by instrument dated March 17, 1978 and recorded April 3, 1978, in Book 595 at Page 503 of the Miscellaneous Records of Douglas County, Nebraska, to construct, operate and maintain a box culvert storm drain and appurtenances in a portion of subject property.

Easements reserved for utilities above, on and below the surface of that portion of vacated 132nd Street included within subject property by Ordinance No. 30095 of the City of Omaha, Nebraska, passed August 30, 1983 and recorded September 16, 1983, in Book 696 at Page 549 of the Miscellaneous Records of Douglas County, Nebraska.
