Partnership represents and warrants it has title in fee to the entirety of the realty subject to said easement conveyance.

It is understood and agreed upon by District and Partnership, their successors and assigns, that this instrument shall be filed of record in the Register of Deeds Office of Sarpy County, Nebraska, and shall run with title to the easement tract involved herein.

For the true and faithful performance of the agreements and covenants above stated, the parties hereto bind themselves, their executors, administrators, and legal representatives, each to the other.
