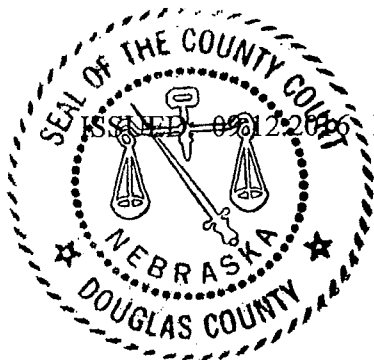

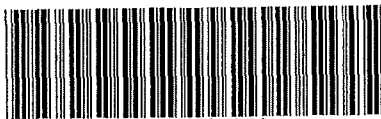

1. Applicant is the son of Decedent, and is an interested person as defined by the Nebraska Probate Code Section 30-2209(21).
2. Name of Decedent: Robert P. Kapoun, Sr., also known as Robert P. Kapoun  
Date of Death: January 3, 2007  
Age at Date of Death: 80 Years  
Domicile at Date of Death: Douglas County, Nebraska
3. Venue for this proceeding is proper in this county because Decedent was a domiciliary of this county at the date of death.
4. No Personal Representative has been appointed in this state or elsewhere.
5. Applicant has not received a Demand for Notice and is unaware of any demand for notice of any probate or appointment proceeding concerning Decedent that may have been filed in this state or elsewhere. However, an inheritance tax proceeding was adjudicated and inheritance tax paid to the Douglas County Treasurer concerning the estate of Decedent in the County Court of Douglas County, Nebraska, Case No. PR 07-1695.
6. After the exercise of reasonable diligence, Applicant is unaware of any unrevoked testamentary instrument relating to property having a situs in this state.
7. Decedent had no surviving spouse, but had four (4) children, whose names are Terry J. Kapoun, Robert A. Kapoun, Marsha A. Bogatz, and Ronald R. Kapoun, who survived Decedent. Robert A. Kapoun as Personal Representative, who is qualified and whose status of priority is as a son of Decedent. The nominated Personal Representative is neither indebted to the estate nor a creditor of the estate.
8. No bond is required because all heirs of Decedent have waived requirement of bond.

The name, relationship and address of Decedent's spouse, children (all of whom are children of any surviving spouse unless otherwise stated), heirs, devisees, and other interested parties, and ages of those who are minors, and those who are incompetent so far as known or ascertainable by reasonable diligence by Applicant, are listed on Schedule "A" attached hereto and made a part hereof by this reference.
10. No child of Decedent has been born since Decedent's death; and no birth of a child of Decedent is anticipated.

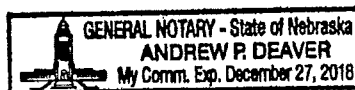
