FIRST AMENDMENT TO MIXED USE DEVELOPMENT AGREEMENT

THIS FIRST AMENDMENT TO MIXED USE DEVELOPMENT AGREEMENT is made pursuant to Article XXII of the Zoning Ordinance of the City of Papillion, and entered into by and between the CITY OF PAPILLION, NEBRASKA, a municipal corporation (hereinafter referred to as "City"), and MARKET POINTE LLC, a Missouri limited liability company (hereinafter referred to as "Developer").

WITNESSETH:

WHEREAS, the City and Developer have entered into a certain Mixed Use Development Agreement that was approved by the City Council of the City of Papillion on July 20, 2004, by Resolution No. R04-0084, (the "Development Agreement"), setting forth certain conditions with respect to the development of property owned by the Developer known as Market Pointe Addition; and

WHEREAS, the Developer desires to amend the Agreement to modify the sign regulations within Market Pointe Addition.

NOW, THEREFORE, the following is agreed between the parties hereto:

- 1. <u>Capitalized Terms</u>. All capitalized terms used in this Second Amendment shall have the meanings set forth in the Agreement except as otherwise defined herein.
- 2. <u>Area of Application</u>. The Development Agreement applies to all lots contained within Market Pointe Addition, Market Pointe Addition Replat 1, Market Pointe Addition Replat 2, Market Pointe Addition Replat 4, and Market Pointe Replat 5.
- 3. <u>Amendment</u>: <u>Exhibit C, Section 8, Subsection C</u> of the Development Agreement is hereby repealed and replaced with the following:

C. Restaurant and Pad

- Tenant sign area shall be on the building faces above the entrances and as part of the building design.
- The maximum height for letters in the body of the sign shall not exceed 36" in height.

- The sign areas shall not exceed ten percent (10%) of the area of the storefront.
- Maximum one sign per storefront with a maximum of (3) three.
- The Planning Director may approve an increase in maximum letter height if all of the following conditions are met:
 - The maximum letter height for the sign attached at the main entrance may not exceed 60".
 - The maximum letter height for signage on secondary facades may not exceed 48".
 - The building is designed for use by only one tenant.
 - o The building size must be greater than 15,000 SF.
 - o Signage shall be illuminated individual letters. Conventional box signs and box signs with raised letters are not permitted.
 - o The size of the letters is appropriately scaled to the building size.
 - o Landlord approval letter specifically states that the increased letter height is acceptable.
- No Other Amendments. Except as specifically set forth herein, the Development Agreement shall remain in full force and effect.

IN WITNESS WHEREOF, the executing parties, by their respective duly authorized agents, have entered into this First Amendment to the Mixed Use Development Agreement effective on the date of City Council approval.
