X The SW 1/4 SW 1/4 of Section 27, Township 17 North, Range 6 East, Saunders County, Nebraska.

X That part of the North half of Section Thirty-four (34) in Township Seventeen (17), North, Range Six (6) East of the 6th Principal Meridian of Saunders County, Nebraska, described as follows:

Commencing at the Northwest corner of said Section Thirty-four (34), thence East along the north line of said section, 2575.37 feet to the place of beginning; thence South to the half section line of said Section Thirty-four (34), to a point 2570.73 feet east of the west line of said Section thirty-four (34) thence East along the half section line of said Section Thirty-four (34), 700.25 feet; thence North to the north line of said Section Thirty-four (34) to a point 3275.74 feet East of the West line of said Section Thirty-four (34); thence West to the place of beginning, containing 42.5 acres, more or less, Saunders County, Nebraska.
