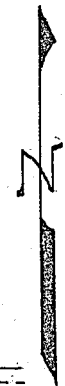
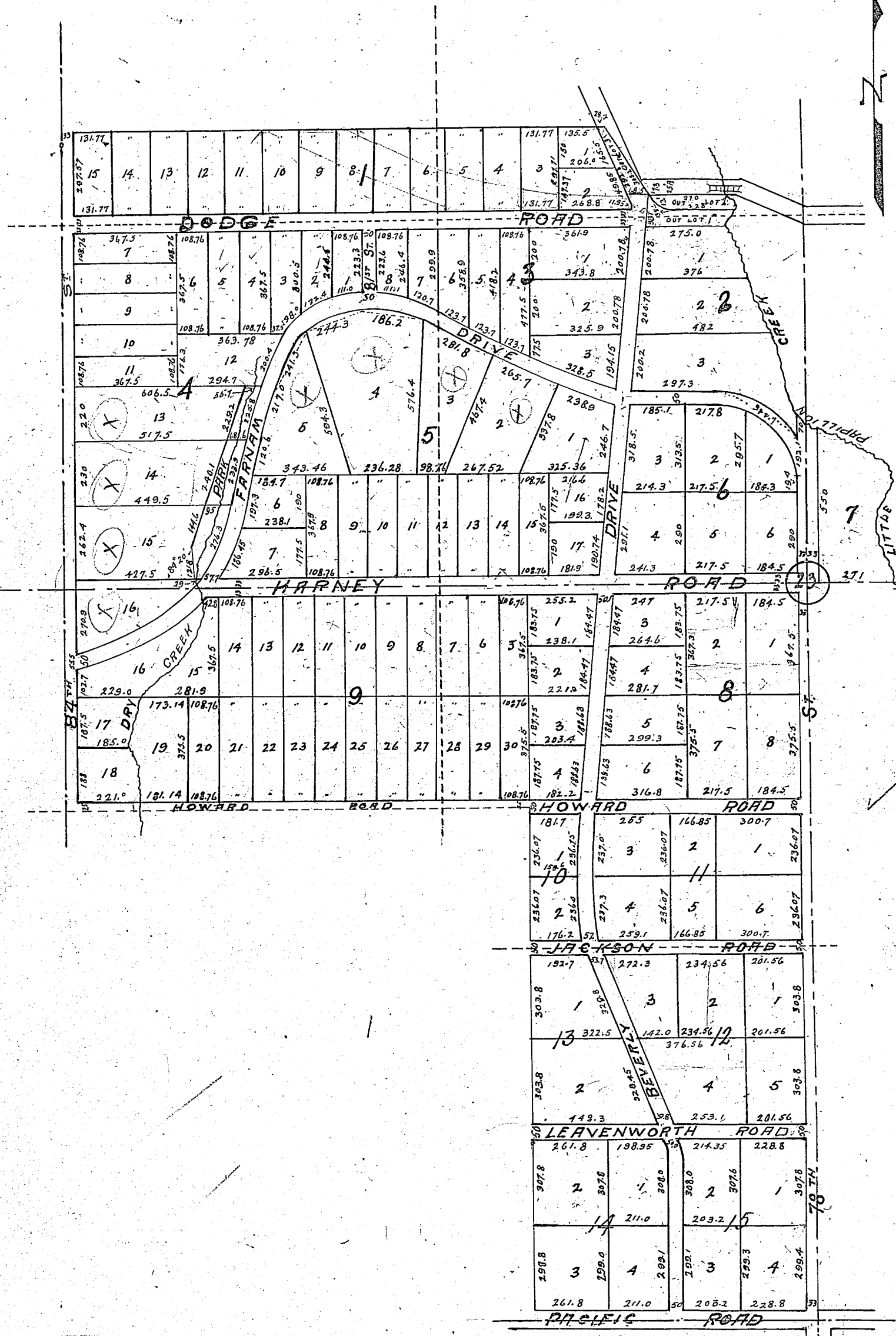

I hereby certify that I have accurately surveyed and staked the Lots, Blocks, Park and Streets of Beverly Hills an addition to Douglas County, as shown by this plat and described as follows. The S. W. 1/4 of the N. W. 1/4 of Section 23, Township 15, Range 12, East of the 6th P. M. also all of the S. E. 1/4 of the N. W. 1/4 of said Section 23 excepting that part lying east of Little Papillion Creek, also that part of the S. W. 1/4 of the N. E. 1/4 of said Section 23 lying West of Little Papillion Creek, also the East 60 Acres of the S. W. 1/4 of said Section 23, also the North 30 acres of the West 100 Acres of the S. W. 1/4 of said Section 23. Also a parcel of land described as follows: Commencing at a point 1322 feet South of the N. W. Corner of said Section 23, thence North 330.57 feet, thence East 1910.31 feet to the West line of Dodge Street Road, thence South-easterly along the South and West line of Dodge Street Road to the intersection of said South line of road and the center of Little Papillion Creek, thence South-easterly along center line of Little Papillion Creek to and intersection of said Creek and a point 1323 feet south of the North line of said Section 23, thence West 2334.2 feet to place of beginning.

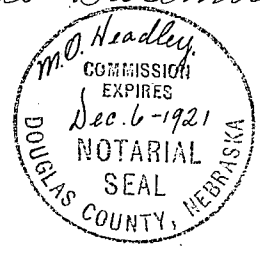

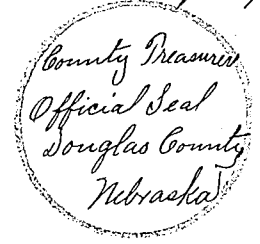
