SECOND AMENDMENT TO CIVIC PARTNERS DEVELOPMENT AGREEMENT

THIS SECOND AMENDMENT made and entered into on **November 4 2002** by and between the City of Sioux City, Iowa, (hereinafter "City") and Civic Partners Sioux City L.L.C., (hereinafter "Redeveloper").

WHEREAS, City and Redeveloper have, pursuant to Resolution No. 2001-1027 passed and approved November 19, 2001, entered into a Development Agreement for the redevelopment of a portion of the Combined Central Sioux City –CBD Urban Renewal Area; and

WHEREAS, City and Redeveloper propose to amend said Development Agreement.

NOW, THEREOFRE, in consideration of the promises and mutual obligations of the parties hereto, each of them does hereby covenant and agree with the other as follows:

- Section 8 of the Development Agreement shall be amended by adding a new subparagraph (k) thereto to read as follows:
 - (k) <u>Legal Description of Phases and Parcels</u>. The Project shall consist of three Phases, each of which shall contain one or more parcels of land as follows:
 - (1) Phase I: Phase I of the Project shall contain the following described property: See attached Plat of Survey.
 - (2) Phase II: Phase II of the Project shall contain the following described property: Lots 1 6, Block 22, Middle Sioux City and the vacated North/South and East/West alleys (including the intersection of said alleys) lying in said Block 22, Middle Sioux City AND Jennings Street abutting Lots 1 6, Block 22, Middle Sioux City EXCEPT those areas which have been identified in Phase I or which may be identified as being needed for future public right-of-way or other public purpose. The exact area of Phase II to be determine and identified on a Plat of Survey at a later date. Said survey to be agreed upon by both the City and the Developer.
 - (3) Phase III: Phase III of the Project shall contain the following described property: Lots 7 12, Block 22, Middle Sioux City and the vacated East/West alley abutting Lot 10 and the vacated North/South alley abutting Lots 10 12, Block 22, Middle Sioux City EXCEPT those areas which have been identified in Phase II or which may be identified as being needed for future public right-of-way or other public purpose. The exact area of Phase III to be determined and identified on a Plat of Survey at a later date. Said survey to be agreed upon by both the City and Developer.
- 2. In all other respects, the Development Agreement entered into by the parties on November 19, 2001, as amended June 10, 2002, be and the same is hereby ratified, confirmed and approved.
