SUBORDINATION, NON-DISTURBANCE AND ATTORNMENT AGREEMENT

This SUBORDINATION, NON-DISTURBANCE AND ATTORNMENT AGREEMENT (this "Agreement") dated the day of Desember, 2006 between Pinnacle Bank a Nebraska Corporation whose address is 13131 West Dodge Road, Omaha, Nebraska, 68154 ("Lender"), and Big Red Lottery Services Ltd., formerly known as Big Red Keno, LTD. ("Big Red").

RECITALS:

- A. Big Red has entered into a Lease Agreement dated August 15, 1996 and recorded in Book 1204 at Page 022 of the Records of Douglas County, Nebraska (the "Lease") with Goodfellas covering certain premises more fully described in the Lease (the "Premises"), which Premises are a part of that the real property legally described as: Lot 5 Block 171, in the Original City of Omaha, as surveyed and lithographed in Douglas County, Nebraska, TOGETHER WITH the South 1 foot in width of that part of the alley in said Block 171 adjoining said Lot 5 on the North. (the "Property")
- B. Lender has made a loan to Patrick L. Venditte and Janet M. Venditte in the sum of \$200,000 secured by a Deed of Trust, Assignment of Lease and Rents and Security Agreement on the Owner and Landlord's interest in the Property and the Deed of Trust is recorded in the official records of the Recorder of Douglas County, Nebraska. (the "Public Records"); Instrument Number \$2007 000 708
- C. Big Red has agreed to the subordination of the Lease to the Security Instrument, Assignment of Lease and Rents and Deed of Trust executed by Patrick L. Venditte and Janet M. Venditte to Pinnacle Bank, a Nebraska Corporation.
