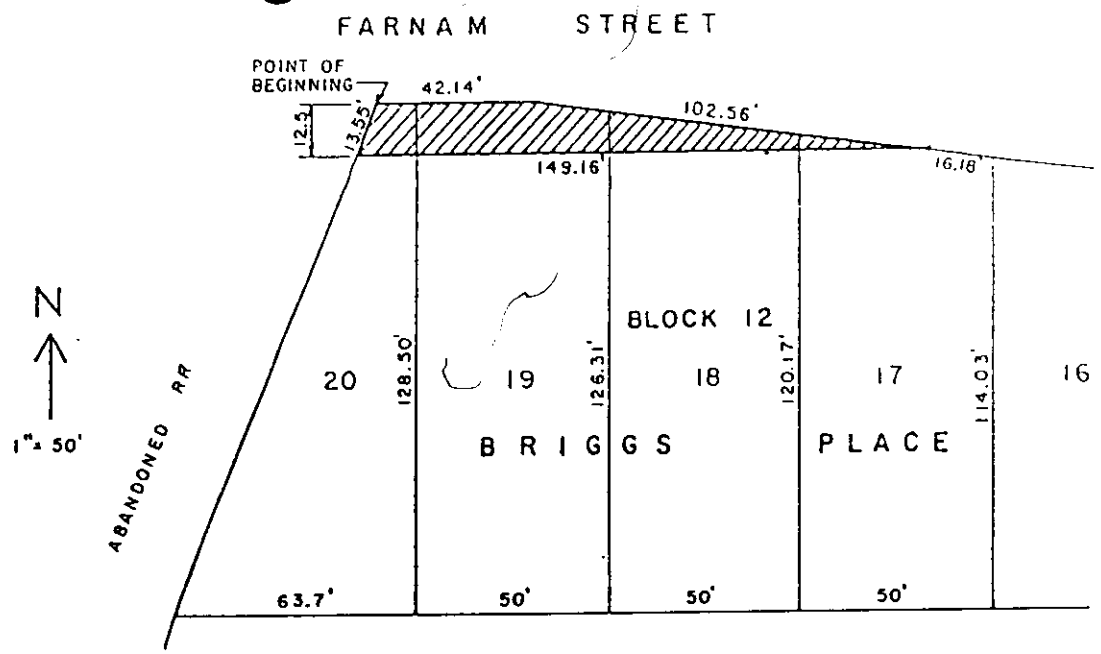

That part of Lots 17, 18, 19, and 20, Block 12, Briggs Place an addition in the City of Omaha, Douglas County, Nebraska as surveyed, platted and recorded, the boundaries of which are described as follows: Beginning at the northwest corner of Lot 20 thence southwest along the west property line a distance of 13.55 feet; thence easterly a distance of 149.16' to a point of intersection of the north property line of Lot 17, said point being 16.18 feet west of the northeast corner of Lot 17; thence northwest along the north property line of Lots 17, 18, and 19 a distance of 102.56 feet; thence west along north property lines of Lots 19 and 20 a distance of 42.14 feet to the point of beginning.

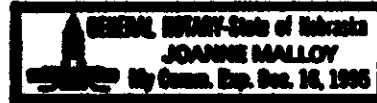
