## DECLARATION OF ASSIGNMENT AND TRANSFER OF PARKING SPACE AND AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR MIDTOWN CROSSING BUILDING 200 CONDOMINIUM

This Declaration made this 14<sup>th</sup> day of April, 2017, by East Campus Realty, LLC, a Nebraska limited liability company, as legal title owner of Condominium Unit 4303 located at 200 South 31<sup>st</sup> Avenue, Omaha, Nebraska ("Transferor") and Anthony M. Smith and Anne M. Smith, as legal title owner of Condominium Unit 4209 located at 200 South 31st Avenue, Omaha, Nebraska ("Transferee").

WHEREAS, Transferor, as the owner of Condominium Unit 4303, has the right to transfer the exclusive use and possession, as a Limited Common Element, of Parking Space No. 2053 ("P-2053"), and

WHEREAS, Transferee, as the owner of Condominium Unit 4209, desires to acquire the right to the exclusive use and possession, as a Limited Common Element, of P-2053, which Parking Space is located at the Condominium, and

WHEREAS, Transferor and Transferee desire that the right to the exclusive use and possession of P-2053 be transferred and assigned to Transferee as the owner of Condominium Unit 4209.

NOW, THEREFORE, pursuant to the terms of the Condominium Property Act of the State of Nebraska and the Declaration of Midtown Crossing Building 200 Condominium ("Condominium Declaration"), recorded in the Office of the Register of Deeds of Douglas County, Nebraska on February 11, 2010, as Document No. 2010012980, as amended, the parties agree as follows:

1. Transferor hereby assigns to Transferee, as owner of Condominium Unit 4209, the right to the exclusive use and possession of **P-2053**, as a Limited Common Element, which right shall be appurtenant to and serve exclusively said Condominium Unit 4209. No other Unit Owners have any right to the use

or possession of **P-2053**. The new legal description of Transferee's Condominium Unit 4209 is described on Exhibit A attached hereto.

- 2. The right to the use and possession of P-2053 being transferred and assigned hereunder is subject to: (a) the Condominium Property Act of the State of Nebraska; (b) the Condominium Declaration and any amendments thereto; (c) such rules and regulations as the Board of Directors of the Midtown Crossing Building 200 Condominium Association, Inc. may from time to time prescribe; and (d) existing leases, liens and encumbrances encumbering the Condominium Unit to which P-2053 is assigned by this Declaration.
